#### 3. Criminal Justice Services Including Behavioral Health Update – Kellie McBride

### a. CJIS RFP Update

The CJIS Review Team is in the process of selecting a vendor to implement the CJIS platform and provide data dashboards. McBride estimates that the implementation will take 18 months.

#### b. Strategic Plan

The CAC is reviewing and providing input on the proposed CJS Strategic Plan 2021-2025. McBride presented an overview of the proposed CJS Strategic Plan, highlighting the nine priorities and the proposed change to the mission statement.
