- a. Introduction of new Deputy DES coordinator
 - i. Kyle Sturgill-Simons introduces Autumn Ashland
 - ii. Autumn introduced herself and proudly stated she is from Los Angeles
 - iii. Al Simons Who is in charge of what in DES? Kyle "TBD"
- b. <u>Presentation Name</u> Al Simons, HAM radio (ARES)
 - i. Have between 20 to 30 folks that are active and check in to regular meetings.
 - ii. Varying levels of training throughout the group
 - iii. Can be backup to internet or radio communications or provide backup radio channels
 - iv. ARES Amateur radio emergency service or CCARC Capital city amateur radio club
 - v. Has repeaters throughout the area some with backup power and some are linked through the internet
 - vi. If repeaters go down they can go simplex which has shorter range

- vii. They have pre stationed radio equipment at the RMETC, DPHHS, St. Petes,
- viii. They have a comm. Trailer with a generator that can travel as needed
- ix. They practice setting up remotely and utilizing their system and communicate in challenging environments
- x. Can send information too, not just voice. Just a much smaller volume due to system capabilities
- xi. Can help with status monitoring and other needs operationally
- xii. 5 OXCOM folks locally that can work within the ICS system in an incident
- xiii. They cannot encrypt, no med or personal information sent
- xiv. They are looking to be involved and participate in trainings and other comms opportunities in the community.
- xv. How do they maintain relationships and contacts with folks?
- xvi. Sue H wonders if they are connected with the 83rd CST, will help to connect.
- xvii. Paul R. wondering if they troubleshoot radio that they have at the VA.
- xviii. Kyle S. says we could build radio freq. in EOP as Comms plan.
- xix. Discussion about encryption and interoperability in the system and how best to accomplish this
- xx. Rocky wonders how many HAM folks would be need to standup comms if current radio system/internet goes down. Lynn Pretty much all the folks they have with their group and would have to work in shifts over time. They have other folks to access in other cities.
