# Contract Between Lewis and Clark and CivicHR. (Aaron Douglas)

Aaron Douglas, HR Analyst, presented the contract between Lewis and Clark County and CivicHR for the purchase of applicant tracking software in the amount of \$6,500 for the first year and \$4,500 every year after. The software will streamline the recruitment process, allow applicants to apply online and will reduce staff time and costs associated with the hiring process.
