The Lewis and Clark County Commissioners Public Meeting was held on Thursday, December 14, 2017, at 9:00 AM in Commission Chambers Room 330.

**Roll Call**

Roger Baltz reported on the consent action items 2 a-b and recommended approval.

**Resolution 2017-158 Ordering the Cancellation of Delinquent Property Taxes on Mobile Home or Housetrailer. (Karie Frydenlund)**

Paulette DeHart, Treasurer/Clerk and Recorder, presented the resolution to order the cancellation of delinquent property taxes on an abandoned mobile home. The mobile home is located within the Buzz In RV Park and Storage. The RV park owner is requesting taxes be removed as they served the appropriate paperwork to the mobile home owner with no response and it has been deemed

abandoned. Lewis and Clark County has also tried to reach the owners. The information was also turned over to the Department of Revenue Offset Program and if the mobile home owners had ever received a refund check a portion of it would have been garnished for the taxes; this has not happened for several years. The RV park owner has indicated they will either destroy or recycle the mobile home.

No public comment was received.

A motion to Approve was made by Commissioner McCormick and seconded by Commissioner Hunthausen. The motion Passed on a 2-0 vote.
