### Roll Call

#### **Consent Action Items**

Eric Bryson reported on the consent action items 2 a and recommended approval.

# <u>Contract between Lewis and Clark City-County Health Department and ElementL Design. (Gayle Shirley)</u>

Gayle Shirley presented the contract between Lewis and Clark City-County Health Department and Element L Design for logo design services. A new name is also part of the re-branding effort which was presented to the Board
