Roll Call

Chairman Andy Hunthausen called the meeting to order at 9 a.m.

Standard Audit Contract between Lewis & Clark County and Anderson ZurMuehlen. (Nancy Everson)

Nancy Everson, Finance Director, presented the standard audit contract between Lewis & Clark County and Anderson ZurMuehlen. This is a one year

extension to the current 3 year contract for fiscal year 15 in the amount of \$49,500.

SHPO Local Certified Grant Award by Lewis & Clark County Heritage Tourism Council. (Pam Attardo)

Pam Attardo, Historic Preservation Officer, presented the SHPO local certified grant award by Lewis & Clark County Heritage Tourism Council. This is the annual grant for the Historic Preservation Office in the amount of \$5,500.

Commissioner Geise asked where the funds come from

Pam Attardo stated that the funds come from the state and federal government. The funds are used for the operation of their office and exhibits. A current exhibit in the works is, "Helena as She is". The exhibit focuses on what we have left and is an architectural exhibit.
