April 16, 2020 MINUTES

The Lewis and Clark County Commissioners Public Meeting was held on Thursday, April 16, 2020, at 9:00 AM in Zoom Meeting https://zoom.us/j/5669454978.

Roll Call

Chair Susan Good Geise called the meeting to order at 9 a.m.

Commissioner Andy Hunthausen and Commissioner Jim McCormick were present. Roger Baltz reported on the consent action items 2 a-b and recommended approval.

A motion to Approve was made by Commissioner McCormick and seconded by Commissioner Hunthausen. The motion Passed on a 3-0 vote.

Bid Award. 2020 Bituminous Asphalt Pavement. (Audra Zacherl)

Audra Zacherl, Public Works Assistant Director, presented the bid award for the 2020 purchase of bituminous asphalt pavement by the Road Department for the period beginning May 1, 2020 through June 30, 2021. The asphalt material bid will meet the requirements of Montana Public Works Standard Specifications Sixth Edition, Section 02510. Asphalt material will be produced at the bidder's facility and County crews will transport, place and compact. The successful bidder must be able to provide a minimum of four tons and up to a maximum of 300 tons of the asphalt daily.

Staff recommends awarding the bid to the low bidder, Cap Paving, Inc. of East Helena, Montana for the base bid per ton amount of \$66.00.

Ms. Zacherl explained that reason for the difference between 4 tons and 300 tons needed on a daily basis; some days very little is needed as the crew is only doing pothole patching and some days 300 tons is needed because the crew is doing overlay.

No public comment was received.

A motion to Approve was made by Commissioner McCormick and seconded by Commissioner Hunthausen. The motion Passed on a 3-0 vote.
