The Lewis and Clark County Commissioners Public Meeting was held on Thursday, July 9, 2015, at 9:00 AM in Commission Chambers Room 330.

Roll Call

Chairman Andy Hunthausen called the meeting to order at 9 a.m.

a. Vendor Claims Report for week ending July 10, 2015. (Marni Bentley)

Eric Bryson reported on the consent action item 2 a and recommended approval.

Bid Opening - 2015 Chip Seal Surfacing. (Audra Zacherl)

Jesse Whitford, Construction Coordinator, presented the bid opening for 2015 Chip Seal Surfacing project. There were two bids received. The first bid was from Pavement Maintenance Solutions of Columbia Falls, MT. The bid bond was included and signed along with the federal debarment statement. The total project bid is \$629,023.21. The next bid is from Helena Sand and Gravel of Helena, MT. The bid bond was included and signed along with the federal debarment statement. The total project bid is \$595,595.00.

Art Pembroke, IT&S Director, presented the contract between Lewis & Clark County IT&S and Information Technology Core for technical support services to the IT&S networking staff for emergency and support services as needed basis in an amount not to exceed \$5,000. The contract begins July 1, 2015 and ends June 30, 2016.
