The Lewis and Clark County Commissioners Public Meeting was held on Tuesday, January 24, 2023, at 9:00 AM in Commission Chambers, Room 330.

Roll Call

Contract Agreement Between Lewis and Clark Public Health and Yarrow, LLC. (A.C. Rothenbuecher)

Rothenbuecher, Community Health Promotion Division Administrator, presented a contract agreement with Yarrow, LLC for consulting services for a Social Determinants of Health Accelerator Plan Project in the amount of \$30,000 with a contract period from January 1, 2023 through September 30, 2023. Staff recommends approval of the contract agreement.
