# <u>Professional Services Contract Between Lewis and Clark County and Indoor/Outdoor Environmental, LLC. (Greg McNally)</u>

[10:20] Greg McNally, Community Development and Planning Director, presented a contract with Indoor/Outdoor Environmental, LLC for asbestos and lead-based paint inspection, sampling, and analysis at the 1872 Unionville Schoolhouse. The contract is not to exceed \$1,775.55 and will run until July 31, 2023. Staff recommends approval of the contract.

## Resolution 2023-26 to Authorize Submission of a Community Development Block Grant - Economic Development Application. (Ann McCauley)

- [14:40] Ann McCauley, Grants and Purchasing Director, presented a resolution to authorize the submittal of a Community Development Block Grant - Economic Development (CDBG-ED) application to the Montana Department of Commerce on behalf of Florence Crittenton Family Services. The grant request is \$525,000 with a match of \$525,000 from Florence Crittenton. The anticipated period of performance is July 2023 through March 2024. Staff recommends approval of the grant application.
- [17:13] Carrie Krepps, Florence Crittenton Executive Director, presented program information including workforce development, mental health and substance abuse, housing, and childcare. If awarded, the grant will provide increased capacity at the Youth Maternity Home and the new childcare center.

# Amendment No. 1 to Grant Award Between Lewis and Clark County and Montana Disaster and Emergency Services. (Ann McCauley)

[52:53] Ann McCauley, Grants and Purchasing Director, presented an amendment to a grant award with Montana Disaster and Emergency Services for the Hazard Mitigation Grant Program-Post Fire grant for the North Hills Fire Mitigation project. The amendment changes the scope of work for three properties and extends the period of performance to March 31, 2024. Staff recommends approval of the amendment.
