

#### **PUBLIC MEETING**

May 23, 2024 MINUTES

The Lewis and Clark County Commissioners Public Meeting was held on Thursday, May 23, 2024, at 9:00 AM in Commission Chambers, Rm 330.

#### Roll Call

#### Upper 10 Mile Project Update from Montana Department of Environmental Quality. (Dick Sloan)

[7:53] Dick Sloan, Department of Environmental Quality; Chapin Storrar; and Trent Thomas gave an update on the Upper 10 Mile superfund project and a history of the mines contributing to creek contamination.

No public comment was received.

### Bid Opening. Country Club Overlay. (Dan Karlin)

[27:15] Dan Karlin, Engineer, presented the bid opening. Two bids were received. The first bid is from Helena Sand & Gravel of Helena, Montana, schedule 1 for \$274,316.50 and schedule 2 for \$270,355. The second bid is from Hoffman R & M Services and Excavation, schedule 1 for \$337,387 and schedule 2 for \$332,105. Staff would like to take the bids under advisement and return with recommendation on June 6, 2024.

#### Bid Opening. Country Club Chip Seal. (Dan Karlin)

[31:43] Dan Karlin, Engineer, presented the bid opening. Two bids were received. The first bid is from Bullock Contracting of Boulder, MT for \$86,073.68. The second bid is from Helena Sand & Gravel of Helena, MT for \$113,222.32. Staff would like to take the bids under advisement and return with recommendation on June 6, 2024.

A motion was made by Commissioner Rolfe for staff to take the bids under advisement and make a recommendation to the Commission on June 6, 2024. The motion was seconded by Commissioner Payne. The motion Passed on a 2-0 vote.

# Grant Award Contract Between Lewis and Clark County and the Montana Department of Commerce. (Dan Karlin)

[35:08] Dan Karlin, Engineer, presented the grant award from the Department of Commerce for funds from the Montana Coal Endowment Program (MCEP) in the amount of \$32,000 to complete a Preliminary Engineering Report (PER) that meets all requirements for infrastructure planning grants, and to submit one electronic copy of the PER to the Department. There is a 20% match, up to \$8,000 for a total project cost of \$40,000. The project selected for the funds is the Augusta-Clemons bridge. Staff recommends approval.

No public comment was received.

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Payne. The motion Passed on a 2-0 vote.

## Resolution 2024-35 Intention to Create the Oro Fino Rural Improvement District No. 2024-2. (Jessica Makus)

[38:46] Jessica Makus, Special Districts Program Coordinator, presented the resolution of intention to create the Oro Fino Rural Improvement District (RID). Staff received a petition to create a new RID signed by 75% of the property owners, for the purpose of improving and maintaining Menlo Park Road, Lodestar Road, Homestake Drive, a portion of Bernice Drive. The original RID was created in 1994 to maintain the roads and the improvements have reached their functional life and no longer benefit from maintenance. There are 36 properties in the proposed district. The estimated financing is \$317,641 with a 15-year debt service assessment of \$909 per benefiting property annually with an additional \$230 annually for maintenance. Staff recommends approval of the resolution.

No public comment was received.

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Payne. The motion Passed on a 2-0 vote.

### Extended Warranty Between Lewis and Clark County and NomadGCS. (Greg Holmlund)

[46:34] Greg Holmlund, Sheriff's Office Sergeant, presented an extended warranty with Nomad GCS for the Sheriff's Office new command vehicle for annual payments of \$32,676.19 for a total contract amount of \$228,733.34. The warranty begins May 2025 through May 2032. Staff recommends approval of the warranty.

Leo Dutton, Sheriff/Coroner, stated this is included in the Sheriff's Office budget.

No public comment was received.

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Payne. The motion Passed on a 2-0 vote.

# Grant Contract Between Lewis and Clark County and the Montana Department of Environmental Quality. (Laurel Riek)

[58:37] Drenda Niemann, Public Health Officer, presented the grant award renewal with the Montana Department of Environmental Quality in the amount of \$21,227 for the Air Pollution Control Program, a long-standing contract. The grant contract begins July 1, 2024 through June 30, 2026. Staff recommends approval of the grant award.

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Payne. The motion Passed on a 2-0 vote.

## <u>Contract Extension Between Lewis and Clark County and Diamond Construction, Inc. (Pam Attardo)</u>

[1:03:39] Pam Attardo, Historic Preservation Officer, presented the extension to the existing contract with Diamond Construction, Inc. for repair of the rafters and hanging drywall in the vestibule of the Unionville School. The extension would go to August 26, 2024. Staff recommends approval of the contract extension.

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Payne. The motion Passed on a 2-0 vote.

#### Contract Extension Between Lewis and Clark County and Eagle Electric, Inc. (Pam Attardo)

[1:05:39] Pam Attardo, Historic Preservation Officer, presented the extension to the existing contract with Eagle Electric, Inc. for electrical services for the Unionville School. The extension is to August 26, 2024. Staff recommends approval of the contract extension.

The extension to August 26, 2024. Staff recommends approval of the contract extension.
