

# PUBLIC MEETING May 14, 2024 MINUTES

The Lewis and Clark County Commissioners Public Meeting was held on Tuesday, May 14, 2024, at 9:00 AM in Commission Chambers, Rm 330.

### Roll Call

## Resolution 2024-25. To Levy and Assess the Lake Home Road Rural Improvement District No. 2020-1. (Jessica Makus)

[2:55] Jessica Makus, Special Districts Program Coordinator, presented a resolution to levy and assess the Lake Home Road Rural Improvement District (RID) an annual special assessment of \$92 upon the 14 benefiting properties for a total of \$1,288 annually to fund the maintenance. A meeting was held with residents on March 15 with two attendees. Staff recommends approval of the resolution.

No public comment was received.

A motion to Approve was made by Commissioner Payne and seconded by Commissioner Rolfe. The motion Passed on a 3-0 vote.

### Resolution 2024-26. To Levy and Assess the Hahn Road Rural Improvement District No. 2023-1. (Jessica Makus)

[9:56] Jessica Makus, Special Districts Program Coordinator, presented the resolution to levy and assess the Hahn Road Rural Improvement District (RID) \$130 upon the 50 benefiting properties for an annual maintenance assessment total of \$6,500. A meeting was held February 27, 2024 with a total of 5 attendees. Staff recommends approval of the resolution.

### Contract Amendment No.1 Between Lewis and Clark County and JHS, Inc. (Christian Lehnert)

[15:05] Christian Lehnert, Noxious Weed Coordinator, presented the contract amendment to the JHS, Inc. contract that was put in place May 4, 2023, and is a three-year services contract. Mr. Lehnert highlighted line J that was added in the amendment that specifically lists the deliverables. He added the contract amount of \$228,550 will remain the same for the Helena Valley Mosquito District. Staff recommends approval of the amendment.

No public comment was received.

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Payne. The motion Passed on a 3-0 vote.

### Contract Amendment No. 1 Between Lewis and Clark County and JHS, Inc. (Christian Lehnert)

[23:48] Christian Lehnert, Noxious Weed Coordinator, presented the amendment to the JHS, Inc. contract that was put in place May 4, 2023, and is a three-year services contract. Mr. Lehnert highlighted line I that was added in the amendment that specifically lists the deliverables. He added the contract amount of \$16,800 will remain the same for the Craig/Wolf Creek Mosquito District. Staff recommends approval of the amendment to the contract.

# Memorandum of Agreement Between Lewis and Clark County and the Montana Department of Environmental Quality. (Dan Karlin)

[27:42] Dan Karlin, Engineer, presented the memorandum of agreement with the Montana Department of Environment Quality (DEQ) to coordinate efforts for grant support associated with the Upper Blackfoot Mining Complex relocating underground power line for water treatment plant facility. There is no cost to the County and any administrative time will be reimbursed. Staff recommends approval of the memorandum of agreement.

No public comment was received.

A motion to Approve was made by Commissioner Payne and seconded by Commissioner Rolfe. The motion Passed on a 3-0 vote.

### <u>Grant Application to the Montana Department of Natural Resources and Conservation. (Dan Karlin)</u>

[37:12] Dan Karlin, Engineer, presented the grant application to the Montana Department of Natural Resources and Conservation for a reclamation and development grant to relocate the underground powerline for the Upper Blackfoot Mining Complex water treatment plant. The grant amount is \$487,165.80 with no match or cost to Lewis and Clark County. Staff recommends approval of the grant application.

The grant period is from October 1, 2023 through September 29, 2024. Staff recommends acceptance of the grant award.
