On November 7, 2014, the Scratch Gravel Solid Waste District received a request for a solid waste refund from Kelly Borsberry, 1918 Wilder St, Helena MT.

Mr. Borsberry states he tore down the house in 2009 and has not rebuilt.

Per Cheryl Green, Property Tax Supervisor, this property was assessed in 2010, 2011, 2012 and 2013 for the Scratch Gravel Solid Waste District.

Mr. Borsberry used the solid waste permit in 2010 and therefore does not qualify for reimbursement, however he did not use the permits for 2011, 2012 and 2013. The assessment was removed in 2014 and the permit for Fiscal Year 2015 has been canceled.

Staff recommends the Board approve reimbursement of the 2011, 2012 and 2013 assessments for a total of \$282.
