# A RESOLUTION CALLING FOR AN ELECTION AND ESTABLISHING THE ELECTION DATE ON THE QUESTION OF INCORPORATION OF THE TEN MILE/PLEASANT VALLEY COUNTY SEWER DISTRICT AS THE TEN MILE/PLEASANT VALLEY COUNTY WATER AND SEWER DISTRICT

WHEREAS, the Board of County Commissioners of Lewis and Clark County have received a petition containing the signatures of at least 10% of the registered voters of the territory within the Ten Mile/Pleasant Valley County Sewer District to be included within the proposed district per § 7-13-2204, MCA; and

WHEREAS, petitioners within the Ten Mile/Pleasant Valley County Sewer District wish to establish authority to conduct business related to water facilities within the District; and

WHEREAS, the petition is attached to and recorded with this resolution as "Petition Exhibit"; and

WHEREAS, the Board of County Commissioners have noticed a public hearing as required by § 7-13-2205, MCA; and

WHEREAS, the Board of County Commissioners have held a public hearing on the petition per § 7-13-2206, MCA, to consider the petition and those appearing thereon, together with such written protests as have been filed with the County Clerk and Recorder prior to the hearing by or on behalf of owners of taxable property situated within the boundaries of the proposed district, for a period not exceeding 4 weeks in all; and

WHEREAS, the Board of County Commissioners have, upon the final hearing, made any changes in the proposed boundaries within the county that are considered advisable and defined and established the boundaries as provided in § 7-13-2208, MCA: and

WHEREAS, the Board of County Commissioners has reviewed the boundaries and found a necessity to include three additional properties which were erroneously excluded from Resolution 2007-26 establishing the District, but were included in the election, are connected to the water and wastewater infrastructure and have assisted with the purchase of the new infrastructure; and

WHEREAS, "Staff Exhibit C" describes and "Staff Exhibit D" shows the boundaries upon which the election shall be held. "Staff Exhibit C" and "Staff Exhibit D" reflect properties incorporated within the Ten Mile/Pleasant Valley County Sewer District through Lewis and Clark County Resolution 2007-26 and Ten Mile/Pleasant Valley County Sewer District Ordinance 1, both having been filed with the Secretary of State's Office and properties erroneously excluded; and

WHEREAS the Commission has requested the election to be conducted through a mail ballot election; and

NOW, THEREFORE, BE IT RESOLVED pursuant to Title 7, Chapter 13, Part 22 and Part 23, MCA. As follows:

- 1. The Commission has determined that the petition complies with the requirements of the provisions of § 7-13-2204, MCA.
- 2. The boundaries of the proposed district shall include the properties as identified through "Staff Exhibit C" and "Staff Exhibit D" attached to this Resolution.
- 3. The Commission now calls for an election to be held in the proposed district for the purpose of determining whether the district is to be incorporated through §7-13-22 & §7-13-23, MCA.
- 4. The Commission has requested the election to be conducted through a mail ballot election as provided for in §7-13-2208(2), MCA.

BE IT FURTHER RESOLVED pursuant to 7-13-2208, MCA, the Board of County Commissioners of Lewis and Clark County effectively establish the date, August 26, 2014, for an election to be held for the purpose of determining whether the district is to be incorporated, combined with the election of the directors; through mail ballot election.

BE IT FURTHER RESOLVED that an individual who is the owner of the real property described in 7-13-2212, subsection (1), need not possess the qualifications required of an elector in 13-1-111(1)(c), provided that the elector is qualified if registered to vote in any state of the United States and files proof of registration with the election administrator at least 40 days prior, being July 17, 2014, to the election in which the individual intends to vote.
