RESOLUTION 2015-147

RESOLUTION RENAMING N FOURTH ST. TO WYLIE DR.

WHEREAS, Section 76-1-102, MCA, enables local government to enact procedures which promote the health, safety and general welfare of the public; and,

WHEREAS, a coordinated system of addressing and road naming can accurately describe locations, providing for more efficient delivery of said services by reducing response times and associated costs, pursuant to Resolution 2004-16; and,

WHEREAS, the Lewis and Clark County Board of Commissioners (Board of County Commissioners) authorized the City-County Address Coordinator to: (1) administer a coordinated system of addressing and road naming in areas of the County, as needed; (2) charge appropriate fees for such services; and (3) maintain a dialogue with service providers to promote the implementation of the addressing and road naming system, pursuant to Resolution 2004-16; and,

WHEREAS, the City-County Address Coordinator may find it necessary to re-assign presently used addresses and road names in an effort to provide a coordinated and reliable system of identifying locations within the jurisdiction, pursuant to Resolution 2004-16; and,

WHEREAS, no roadway shall be given a name that is currently in use elsewhere in the County, pursuant to Section 4.13.1.h, Lewis and Clark County Public Works Manual; and,

WHEREAS, no roadway shall be given a name that sounds the same as another road name currently in use elsewhere in the County, pursuant to Section 4.13.1.i, Lewis and Clark County Public Works Manual; and,

WHEREAS, whenever possible, extensions of roadways crossing jurisdictional boundaries shall use the same name on either side of the boundary, pursuant to Section 4.13.1.q, Lewis and Clark County Public Works Manual; and,

WHEREAS, extensions of roadways shall be named the same as the road from which they extend, pursuant to Section 4.13.1.r, Lewis and Clark County Public Works Manual; and,

WHEREAS, the road extending from E US Highway 12 north has two road names, Wylie Dr. and N Fourth St.; and,

WHEREAS, the road name Wylie Dr, is used except for two blocks located within the City of East Helena; and,

WHEREAS, the name of the road should be consistent to ensure a coordinated and reliable system of identifying locations within the jurisdiction; and

WHEREAS, Northwestern Energy owns the only property addressed off of N Fourth St.; and

WHEREAS, on Friday, March 13, 2015, a letter was received by the City-County Addressing Office acknowledging that Northwestern Energy (Gate Station at 112 N Fourth St.) does not oppose the road renaming and address reassignment; and,

WHEREAS, on Tuesday, April 7, 2015, the East Helena City Council held a public hearing regarding the request to rename N Fourth St.; and,

WHEREAS, the East Helena City Council voted to rename N Fourth St. to Wylie Dr. from the intersection of W Riggs St. to the intersection of W Gail St.; and,

WHEREAS, on Tuesday, October 13, 2015, the Board of County Commissioners held a public hearing regarding the request to rename N Fourth St.; and,

WHEREAS, the Board of County Commissioners voted to rename N Fourth St. to Wylie Dr. from the intersection of W Riggs St. to the intersection of W Gail St.; and,

NOW, THEREFORE, BE IT RESOLVED that the N Fourth St. road name, located in the SW ¼ of Section 25, T10N, R3W, Lewis and Clark County, Montana, is hereby retired as shown on attached Exhibit "A"; and,

BE IT FURTHER RESOLVED that N Fourth St., located in the SW ¼ of Section 25, T10N, R3W, Lewis and Clark County, Montana, is renamed to Wylie Dr. from the intersection of W Riggs St. to the intersection of W Gail St.
