A RESOLUTION SETTING THE SALARIES FOR CERTAIN ELECTED OFFICIALS

WHEREAS, MCA § 7-4-2503, establishes the manner in which the compensation for elected officials will be established; and

WHEREAS, MCA § 7-4-2503, requires the County to create a Compensation Board to review elected officials' salaries annually in order to set compensation for elected county officers; and

WHEREAS, the Compensation Board held informational meetings and public hearings with regard to elected officials' compensation; and

WHEREAS, MCA § 7-4-2503, requires the Compensation Board to recommend a compensation schedule that is endorsed by a majority of the board and at least two county commissioners; and

WHEREAS, MCA § 7-4-2107, requires that each County Commissioner receive a salary equivalent to the base salary provided for in MCA § 7-4-2503, plus \$2,000; and

WHEREAS, MCA § 7-4-2503, requires that the Sheriff receive compensation equivalent to the base salary provided for in MCA § 7-4-2503, plus \$2,000, plus longevity in the amount of 1% of the base salary for each year of service; and

WHEREAS, MCA § 7-4-2503, requires that the Superintendent of Schools receive compensation equivalent to the base salary provided for in MCA § 7-4-2503, and allows an increase up to \$2000 if the Superintendent holds a Masters Degree; and

WHEREAS, MCA § 7-4-2301, allows the Board of County Commissioners to consolidate two or more offices and combine the powers and duties of the consolidated offices; and

WHEREAS, MCA § 7-4-2312, requires the Board of County Commissioners to increase the compensation of consolidated offices not to exceed 20% of the base salary provided for in MCA § 7-4-2503; and

WHEREAS, the Commission did consolidate the offices of County Treasurer and County Clerk and Recorder through Resolution 1990-7 and did increase the salary of the consolidated office by \$2000 through Resolution 1991-76 as provided by MCA § 7-4-2312; and

WHEREAS, MCA § 7-4-2503, requires that the County Treasurer receive compensation equivalent to the base salary provided for in MCA § 7-4-2503, and allows an increase up to \$2000; and

WHEREAS, MCA § 7-4-2503, requires that the Clerk and Recorder receive compensation equivalent to the base salary provided for in MCA § 7-4-2503, and allows an increase up to \$2000 if the clerk and recorder is also the county election administrator; and

WHEREAS, the Commission did vote to increase the salary of the of the Clerk of the District Court and Justice of the Peace by \$2000 through Resolution 2015- as provided by MCA 7-4-2503(2)(e) (2015),

NOW, THEREFORE, BE IT RESOLVED, that the Commission adopts the Compensation Board's May 4, 2015, recommended compensation schedule attached by reference to this resolution.
