I went up to property revenue on Broadway Avenue in Helena, in 2014 and talked to Tom, he is the assessor for my district. He showed me pictures of my property and said it was correct and I told him it wasn't because my property isn't a stick built house, it is a 1968 Detroiter mobile home. Then he went and got his supervisor and she said she isn't going to tax it as a double wide when it is a stick built house. Then the conversation got very heated from there on. She said from looking at the pictures it would be a manufacturer home. I told her no, it isn't. I asked for them to come out and re asset my property. And she said no they don't need to because they can see from the pictures that they are correct.

I went back up there days later with 3 metal plates from my mobile that describes my mobile. Once they looked at the plates they said they needed to come out and look at the home. When Tom arrived, he right away said it looks like a double wide. And on further inspection he said it is a double wide. And for this district he only does appraisals for stick built homes. He did go under my home and take pictures. He came inside and inspected the bathrooms. There are no exhaust vents in my bathrooms but he said that was ok because in 1969 there was a law that you had to have them. So this is a 1968 mobile. Then he measured the outside of the mobile and garage. He did ask if there was any water, sewer or bedrooms in the garage. I told him no and he could inspect if he wanted to but he didn't. He then said they would have it re assessed. It took months to get it changed.

The person at property revenue said they are not in the business to refund money for their mistakes. I would have to get a lawyer and deal with the county commissioners.

I'm asking for you to review all of my pass property records to see how much I have over paid. I would like to receive a refund of monies owed to me. I have been advised by counsel; I can only request a refund for the past years of 2012, 2013 & 2014.
