

**RESOLUTION 2018-114**

**A FIRST AMENDMENT TO RESOLUTION 2018-55 TO THE BOARD OF COUNTY COMMISSIONERS OF LEWIS AND CLARK COUNTY, MONTANA PERTAINING TO THE INTENTION TO CREATE THE 4X4 RURAL IMPROVEMENT DISTRICT NO. 2018-01**

**WHEREAS**, the Lewis and Clark County Board of Commissioners (Commission) are authorized to create Resolution 2018-114, amending Resolution 2018-55, a Resolution of Intention to Create the 4x4 Rural Improvement District (RID) 2018-01, whenever the public interest or convenience may require, Section 7-12-2103, MCA; and

**WHEREAS**, the properties within the District are benefitted properties and their benefit is proportional to the fee to be assessed; and

**WHEREAS**, this resolution provides an equitable method for assessing benefitted properties in the District based upon the benefits received; and

**WHEREAS**, the designated items set forth in Section 7-12-2103(2), MCA are as follows;

- (a) The designated number of the District is 2018-01; and
- (b) The roads proposed to be improved and maintained within the boundary of the District are shown on Exhibit "A"; and
- (c) The general character of improvements includes, but is not limited to, soil stabilization and dust control, as detailed by Exhibit "B".
- (d) The estimated annual cost of maintenance is \$9,021.60 or \$74.56 per benefitted property per year, following the first tax year, as detailed by Exhibit "B".
- (e) The County Engineer or a designee is the engineer to have charge of the work. The estimated construction cost to finance said improvements is \$9,695.19 or \$80.13 per benefitted property for the first tax year as detailed on Exhibit "B".
- (f) The costs shall be assessed equally, as described in Section 7-12-2151(d), MCA: "each lot, tract, or parcel of land in the district may be assessed an equal amount based upon the total cost of the improvements [and maintenance]".
- (g) Pursuant to Section 7-12-2103(2), MCA, "if an increase occurs in the number of benefitted lots, tracts, or parcels within the boundaries of the [amended] district during the term of the bonded indebtedness, the assessment per lot, tract, or parcel then in the district will be recalculated as provided in [Section] 7-12-2151(4)", MCA.



**WHEREAS**, the Commission acknowledged, at their December 7, 2018 Public Hearing, that it considered it both advisable and necessary to create the District, to be hereinafter known as the 4x4 Rural Improvement District No. 2018-01, for the purposes of soil stabilization and dust control for the 4x4 road as requested by the petitioners.

**NOW, THEREFORE, BE IT RESOLVED** that the Commission does hereby amend the Resolution of Intention to Create the 4x4 Rural Improvement District 2018-01 for the purpose of equitably funding improvements and maintenance for the 4x4 Road, south of Montana Highway 200, in Lincoln, MT.

**BE IT FURTHER RESOLVED** that the Lewis and Clark County Department of Public Works is authorized and responsible for coordinating proposed improvements and maintenance detailed on Exhibit "B" for roadways within the District.

**INTRODUCED** at a special meeting of the Board of County Commissioners on December this 7<sup>th</sup> Day of December, 2018 by Commission Member Andy Hunthouse.

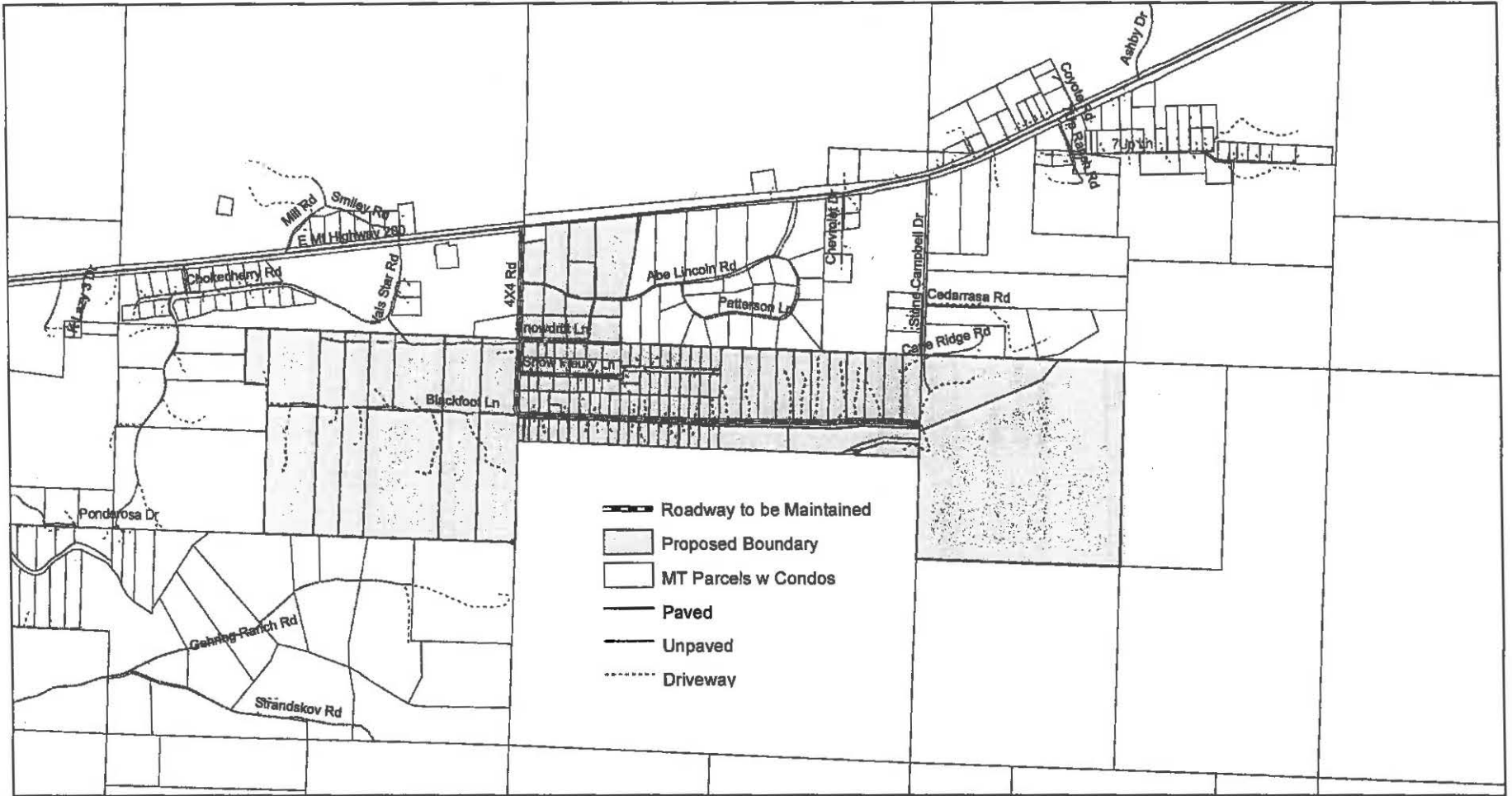
