RESOLUTION OF THE LEWIS AND CLARK COUNTY BOARD OF COMMISSIONERS, SETTING A PUBLIC HEARING DATE ON THE ISSUANCE OF A \$5,400,000 HELENA REGIONAL AIRPORT AUTHORITY REVENUE NOTE, SERIES 2018.

WHEREAS, the Helena Regional Airport Authority (the "Authority") intends to issue up to \$5,400,000 principal amount of a Helena Regional Airport Authority Revenue Note, Series 2018, payable over 22 years with the first two years of interest only payments on the amount drawn and the remaining 20 years of fully amortized principal and interest (the "Note"). The Note will be issued pursuant to Section 67-11-303, MCA, for financing a portion of the costs of expansion and remodel of the Authority's airport terminal building, parking area and jet bridges located at 2850 Mercer Loop in Helena, Montana anticipated to cost \$11.9 million (the "Project");

WHEREAS, the Authority recently completed a selection of the Note purchaser through a Request for Proposal process and intends to sell the Note to Valley Bank of Helena, a division of Glacier Bank, the successful proponent; and

WHEREAS, this Commission intends to hold a public hearing, as required by Section 147 (f) of the internal revenue code of 1986, to determine if the Project and the issuance of the Note by the Authority are in the public interest. The hearing will be held on August 16, 2018, at 9 a.m., M.D.T. in Room 330 of the City/County Building at 316 N. Park Avenue, Helena, Montana.

Notice of the public hearing will be published once in the Helena Independent Record at least two weeks prior to the hearing.
