

RESOLUTION 2019 - 54

A RESOLUTION ORDERING THE CANCELLATION OF
PERSONAL PROPERTY TAXES THAT HAVE BEEN DELINQUENT FOR 5 YEARS

WHEREAS, section 15-16-01, MCA, states the County Treasurer shall prepare and submit to the Board of County Commissioners a list of personal property taxes that are not a lien on personal property and that have been delinquent for five years or more; and

WHEREAS, the Lewis and Clark County Treasurer has submitted the attached Exhibit A to the Lewis and Clark Board of County Commissioners a list of personal property taxes that have been delinquent for five years or more in Lewis and Clark County; and

WHEREAS, section 15-16-702, MCA, states the Board of Commissioners will examine the list and make any necessary corrections within 30 days of receipt; and

WHEREAS, it further states that the Board of County Commissioners shall make its order canceling all such personal property taxes and contractual obligations contained in the list.

NOW, THEREFORE, BE IT RESOLVED, by order of the Lewis and Clark Board of County Commissioners all the delinquent personal property taxes listed on the attached are ordered canceled.

BE IT FURTHER RESOLVED, that upon notification of the order for cancellation, the Lewis and Clark County Treasurer/Clerk and Recorder will adjust their taxes-receivable accounts to conform to this order of cancellation.
