

RESOLUTION 2019 - 84

A RESOLUTION OF CREATION TO ALTER THE BOUNDARIES OF THE TRI-LAKES FIRE SERVICE AREA TO ANNEX ADJACENT WATER BODIES

WHEREAS, the Lewis and Clark County Board of Commissioners (Board) has received a petition requesting to annex certain adjacent water bodies, currently contained within the Lewis and Clark County Fire Service Area into the Tri-Lakes Fire Service Area; and

WHEREAS, said petition was signed by a majority of the owners of real property within the proposed annexation area, pursuant to Section 7-33-2401, MCA; and

WHEREAS, the boundaries of the proposed annexation area are shown in Exhibit "A", attached hereto and made a part hereof; and

WHEREAS, a resolution of intent to alter the boundaries of the Tri-Lakes Fire Service Area to annex adjacent water bodies was adopted by the Board on July 9, 2019 as Resolution 2019-60; and


NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners:

1. That the Board considers it both advisable and necessary to approve this Resolution 2019-84 of Creation to Alter the Boundaries of the Tri-Lakes Fire Service Area to Annex Adjacent Water Bodies.
2. That a public hearing was held on August 29, 2019, at 9:00 a.m. in the Chambers of the Board of County Commissioners, at the City-County Building, Helena, Montana, for the purpose of gathering and receiving testimony, input and comments from all interested or affected users, citizens, persons, associations, corporations and/or companies.
3. That notice of the public hearing was published in the Independent Record pursuant to Section 7-1-2121, MCA.
4. That the annexation will be effective sixty (60) days from August 29, 2019, unless more than 50 percent of property owners within the area of annexation protest, pursuant to Section 7-33-2401, MCA.

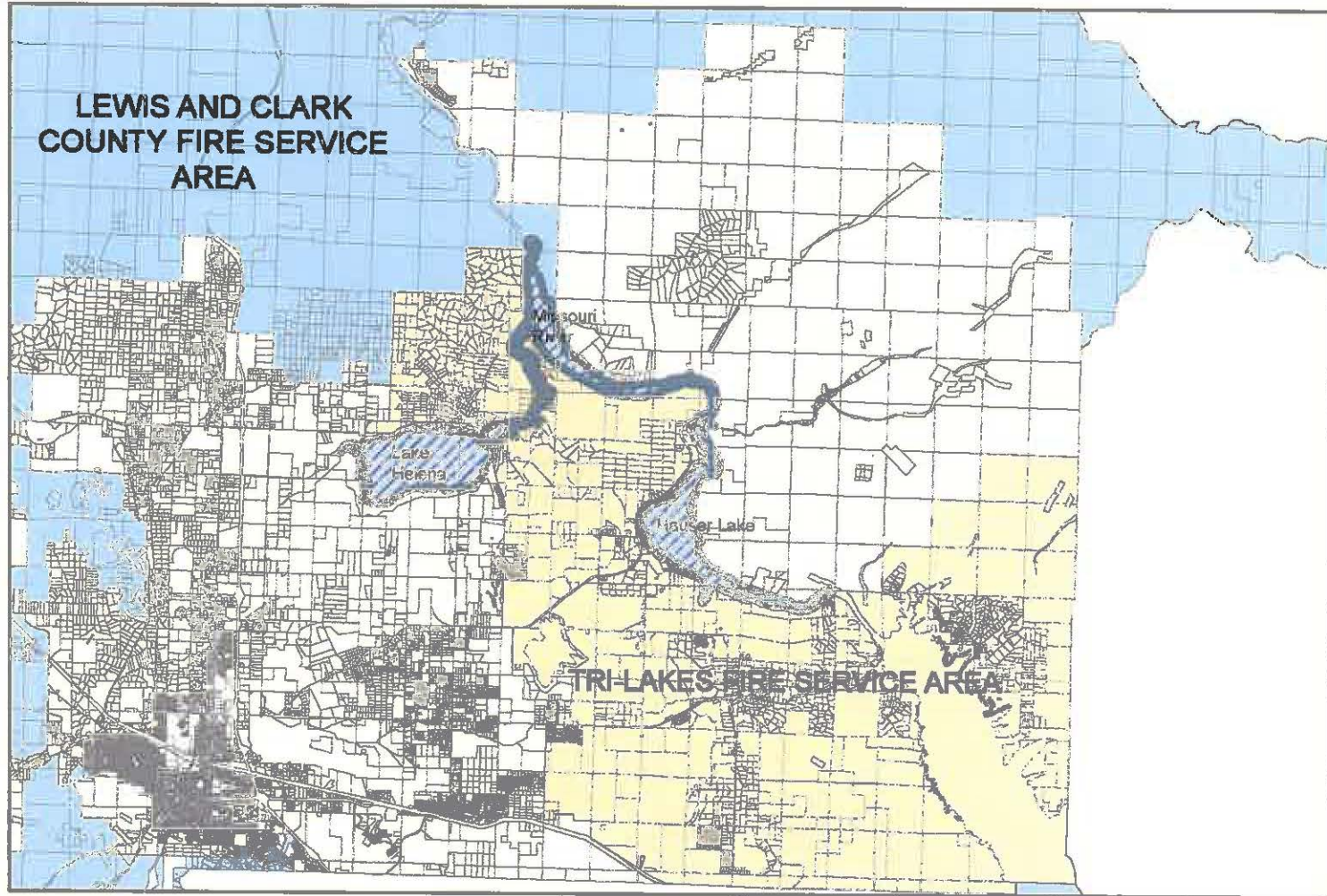
Exhibit "A" to Resolution 2019-84: Map of the Proposed Tri-Lakes Fire Service Area Boundary
