### A RESOLUTION TO CREATE THE MONTANA CITY FIRE DISTRICT NO. 2 (LEWIS AND CLARK COUNTY DIVISION)

WHEREAS, the Lewis and Clark County Board of County Commissioners (Board) is authorized to create rural fire districts as provided by Section 7-33-2101, et. seq., MCA; and

WHEREAS, the Board has received a written petition, attached hereto as Exhibit B, requesting the creation of a rural fire district, to be known as the "Montana City Fire District No. 2 (Lewis and Clark County Division)"; and

WHEREAS, the petition meets the requirements of Section 7-33-2101, MCA, because all the property within the proposed district is unincorporated territory and the petition contains signatures of owners of 100 percent of the real property in the proposed district; and

WHEREAS, the boundaries of the "Montana City Fire District No. 2 (Lewis and Clark County Division)" are within Lewis and Clark County as shown and described on Exhibit A and Exhibit B, attached hereto and made a part thereof; and

WHEREAS, the area of the "Montana City Fire District No. 2 (Lewis and Clark County Division)" is approximately 20.5 acres and is accessed via South Hills Road in Jefferson County or via Lime Kiln Road in Lewis and Clark County; and

WHEREAS, the Montana City Volunteer Fire Department Fire Chief and the Lewis and Clark Fire Service Area Fire Chief have determined that the property in the "Montana City Fire District, Lewis and Clark County Division" would be best served for fire protection purposes by the Montana City Fire District in Jefferson County; and

WHEREAS, the Montana City Volunteer Fire Department Fire Chief has indicated a willingness to enter into a contract with Lewis and Clark County to provide fire protection services to the "Montana City Fire District No. 2 (Lewis and Clark County Division)" after the District is created, and

WHEREAS, all property within the proposed "Montana City Fire District No. 2 (Lewis and Clark County Division)" is no longer a part of the Lewis and Clark Fire Service Area because the creation of the "Montana City Fire District No. 2 (Lewis and Clark County Division)" is effective; and

NOW, THERFORE, BE IT RESOLVED by the Board of County Commissioners:

- 1. That a Public Hearing was held on September 8, 2020 at 9:00 a.m. in the Chambers of the Board of County Commissioners, at the City-County Building, Helena, Montana, for the purpose of gathering and receiving testimony, input and comments from all interested or affected users, citizens, persons, associations, corporations and/or companies.
- 2. That notice of the Public Hearing was published in the Independent Record pursuant to Section 7-1-2121, MCA.
- 3. That notice of the Public Hearing was provided by certified mail to each property owner within the District pursuant to Section 7-1-2122, MCA.






