

RESOLUTION 2020 - 82

**A RESOLUTION LEVYING AN ASSESSMENT UPON CUSTOMERS OF THE SCRATCHGRAVEL SOLID WASTE MANAGEMENT DISTRICT OWNING REAL PROPERTY IN THE DISTRICT AND OWING A PAY-AS-YOU-THROW PROGRAM CHARGE AFTER August 31, 2020**

**WHEREAS**, on March 24, 1999, the Board of Directors for the Scratchgravel Solid Waste District (SGSWD) recommended to the Lewis and Clark County Commissioners that a Pay-As-You-Throw Program (PAYT) be implemented for residences in the SGSWD; and

**WHEREAS**, the Board of Lewis and Clark County Commissioners accepted the recommendation of the SGSWD Board of Directors and directed Public Works Staff to implement a PAYT Program; and

**WHEREAS**, on January 1, 2001, the PAYT Program was implemented for residences in the SGSWD; and

**WHEREAS**, on October 7, 2002 the SGSWD Board directed County Public Works staff to accept payments on PAYT accounts through the second Monday of August of each year to allow for the delivery of payments postmarked by July 31<sup>st</sup>, but not received by the County until a later date; and

**WHEREAS**, on May 12, 2003 the Board of Directors for the SGSWD recommended that the tonnage limit for the PAYT Program be set at 1.5 tons of solid waste per household per year; and

**WHEREAS**, the fiscal year 2020 tipping fee for the City of Helena Transfer Station was \$56.75 per ton for July 1, 2019 through June 30, 2020; and

**WHEREAS**, on July 1, 2020 residences in the SGSWD generating more than 1.5 tons of solid waste were mailed a statement displaying the amount owed, where payments should be mailed, and instructions that if payment was not received by August 31, 2020, the PAYT charge would be added to their tax bill.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Lewis and Clark County that an additional assessment shall be levied and assessed on the 2020 tax bills for those SGSWD residences generating more than the 1.5-ton limit and with a charge owing on their PAYT account after August 31, 2020.

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Lewis and Clark County that a description of each SGSWD residence by solid waste permit number, property owner name, property tax code, and the amount of the annual assessment for each residence is contained on Exhibit A, attached hereto; and
