

RESOLUTION 2021 - 59

**A RESOLUTION ORDERING THE CANCELLATION OF
REAL PROPERTY TAXES THAT HAVE BEEN DELINQUENT FOR 5 YEARS OR MORE**

WHEREAS, section 15-16-701, section (2) (a) MCA, states the County Treasurer shall prepare and submit to the Board of County Commissioners a list of real property taxes that has been delinquent for five years or more; and

WHEREAS, the attached Exhibit A listing of real property taxes that have been delinquent for five years or more in Lewis and Clark County has been submitted by the County Treasurer; and

WHEREAS, section 15-16-701 (2) (a), MCA states, at the time the list is prepared as provided in subsection (1)(a), the county treasurer may prepare and submit to the board of county commissioners of the county a list of the real property taxes that have been delinquent for 5 years or more. To be included on the list, the county treasurer must have attached a tax lien to each property as provided in chapter 17 at least 3 years before preparation of the list; and

WHEREAS, section 15-16-702, MCA, states the Board of Commissioners will examine the list and make any necessary corrections within 30 days of receipt; and

WHEREAS, it further states that the Board of County Commissioners shall make its order canceling all such real property taxes and contractual obligations contained in the list.

NOW, THEREFORE, BE IT RESOLVED, by order of the Lewis and Clark Board of County Commissioners all the delinquent real property taxes listed on the attached are ordered canceled.

BE IN FURTHER RESOLVED, that upon notification of the order for cancellation, the Lewis and Clark County Treasurer/Clerk and Recorder will adjust their taxes-receivable accounts to conform to this order of cancellation.
