A RESOLUTION TO DECLARE VALLEY DRIVE A COUNTY ROAD

WHEREAS, the Board of County Commissions has the authority to approve the Resolution declaring Valley Drive a County Road pursuant to 7-14-2101(4)(b)(i), MCA; and

WHEREAS, Valley Drive was petitioned and surveyed and declared a public highway on November 5, 1909, by the Board of County Commissioners.

WHEREAS, the County received a request from the staff of Lewis and Clark County to make Valley Drive a County Road.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners hereby declare Valley Drive a County Road, as depicted on attached Exhibits A and B, and as kept in the official records of Lewis and Clark County.

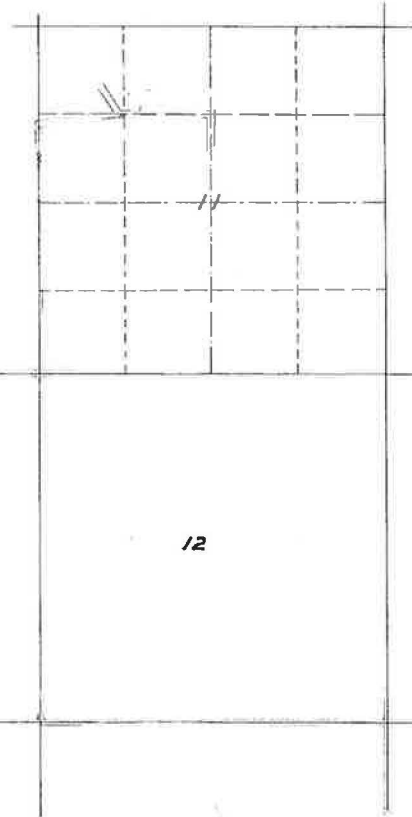


EAST HELENA - VALLEY ROAD
