

**RESOLUTION 2023 - 33**

**A RESOLUTION OF INTENT TO DECREASE THE SOLID WASTE OPERATION AND MAINTENANCE FEE OF THE MARYSVILLE SOLID WASTE SUBSERVICE AREA ESTABLISHED BY THE SCRATCH GRAVEL SOLID WASTE DISTRICT BOARD BEGINNING JULY 1, 2023**

**WHEREAS**, 7-11-1024, MCA states the Board of County Commissioners may make assessments or impose fees for the costs and expenses of special districts based upon a budget proposed by a separate board administering the district; and

**WHEREAS**, the Board of County Commissioners created the Marysville Solid Waste Subservice Area of the Scratch Gravel Solid Waste District on August 1, 1995, in Resolution 1995-90; and

**WHEREAS**, the Marysville Solid Waste Subservice Area is included in the description of the boundaries of the Scratch Gravel Solid Waste District as described in the resolution amending the Scratch Gravel Solid Waste District and by this reference those boundaries are hereby made a part thereof; and

**WHEREAS**, the Marysville Solid Waste Subservice Area waste disposal site is effectively available only to the residents within the Marysville Solid Waste Subservice Area; and

**WHEREAS**, the cost of operating and maintaining the Marysville Solid Waste Subservice Area has not increased; and

**WHEREAS**, on April 13, 2023, the Scratch Gravel Solid Waste District Board approved decreasing the annual assessment fee for solid waste service from seventy-nine dollars (\$79) per residential unit to sixty-five dollars (\$65) per residential unit, and said assessment will be in addition to the annual Scratch Gravel Solid Waste District assessment fee; and

**WHEREAS**, the new assessment fee for solid waste service will be effective for the 2023 tax bills and will remain in effect until such time as it is changed by the Board of County Commissioners; and

**WHEREAS**, any comments or protests to the proposed assessment fee increase shall be addressed in writing to the Lewis and Clark County Clerk and Recorder's Office, 316 N. Park Avenue, Helena, Montana 59623 prior to Wednesday, June 28, 2023, at 4:00 p.m. local time; and

**WHEREAS**, the Board of County Commissioners shall proceed to hear and pass upon all protests so made at a public hearing on Thursday, June 29, 2023, at 9:00 a.m. in Room 330 of the City-County Building, 316 N. Park Avenue, Helena, Montana.


