

**RESOLUTION 2024 - 51**

**A RESOLUTION ESTABLISHING THE LEWIS AND CLARK COUNTY LANDFILL FEE RATES BEGINNING JULY 1, 2024**

**WHEREAS**, Section 7-13-4108, MCA, states the Board of County Commissioners may establish by resolution, rates for services of the Lewis and Clark County Landfill; and

**WHEREAS**, the Lewis and Clark County Landfill serves the Scratch Gravel Solid Waste District, the Marysville Solid Waste Subservice Area, and the City of Helena; and

**WHEREAS**, the Scratch Gravel Solid Waste District Board and the Board of County Commissioners in Resolution 2023-51 established the current landfill fees.

**WHEREAS**, the Board of Directors for the Scratch Gravel Solid Waste District voted on April 30, 2024, and recommended changes in the landfill fees to maintain and operate the County landfill, purchase equipment, make debt service payments, and to maintain adequate cash reserves.

**WHEREAS**, on May 21, 2024, the Board of County Commissioners passed Resolution 2024-33, A Resolution of Intent to Establish the Lewis and Clark County Landfill Fees, Beginning July 1, 2024; and

**WHEREAS**, on June 18, 2024, the Board of County Commissioners held a public hearing on its intention to establish the County landfill fees; and

**NOW, THEREFORE BE IT RESOLVED** by the Board of County Commissioners of Lewis and Clark County that it does hereby establish the following landfill fee rates to be effective on July 1, 2024:

**Class II Solid Waste Tipping Fees**

*Municipal Solid Waste Tipping Fee	\$24.00 per ton
Dead Animal	\$25.00 per animal
*Contaminated Soil, ½ ton minimum	\$30.00 per ton
<b>*Special Large/Bulky Waste</b>	<b>\$150 plus tipping</b>
Wastewater Screenings	<b>\$24.00 per ton</b>
Violation Fees:	
Mattress or Box Spring, each	\$10.00 plus tipping
Tires, each	\$10.00 plus tipping

**Class IV Construction & Demolition Waste Tipping Fees**

Acceptable Material, min. 500 lb \$5.25	\$21.00 per ton
*Asbestos, ½ ton minimum	\$60.00 per ton
Mobile/Manufactured Home	\$250 plus tipping
Travel Trailers and Boats	\$150 plus tipping
Violation Fees:	
Unacceptable Material	\$75.00 plus \$50.00 per ton tipping

**Special Waste Tipping Fees**

Liquid Waste	<b>\$24.00 per ton</b>
Green/ <b>Food</b> Waste	\$10.00 per ton


