MEASUREMENT AND PAYMENT

PART 1 - GENERAL

1.1 RELATED DOCUMENTS

A. Drawings and Special Provisions of the Contract, including General and Supplementary Conditions and other Division 1 Specification Sections, apply to this Section.

1.2 SUMMARY

A. This Section includes administrative and procedural requirements for measurement and payment.

1.3 DEFINITIONS

A. Unit price is an amount proposed by bidders, stated on the Bid Form, as a price per unit of measurement for materials or services added to or deducted from the Contract Sum by appropriate modification, if estimated quantities of Work required by the Contract Documents are increased or decreased.

1.4 PROCEDURES

- A. Unit prices include all necessary material, plus cost for mobilization, delivery, installation, insurance, overhead, and profit.
- B. Measurement and Payment: The Measurement and Payment sections do not necessarily name all incidental items required to complete the work. The cost of all such incidentals shall be included in the various related items of work. All estimated quantities stipulated in the Bid Forms or other Contract Documents are approximate and are to be used only as a basis for estimating the probable cost of the work and for the purpose of comparing the proposals submitted for the work. It is understood and agreed that the actual amounts of work performed and materials furnished under unit price items may differ from such estimated quantities and the payment for such work and materials shall be based on the actual amount of work done and materials furnished in each case.
- C. Engineer will determine the actual quantities and classifications of Unit Price Work performed by the Contractor.
- D. List of Bid Items: A list of unit Bid Items is included at the end of this Section. Specification Sections referenced in the schedule contain requirements for materials described under each Bid Item.

A. MOBILIZATION:

- 1. Description: Mobilization IS NOT A BID ITEM. Mobilization is incidental to the project, and no separate payment will be made. Mobilization is the preparatory work and operations including, but not limited to, those necessary for the movement of personnel, equipment, supplies and incidentals to the project site; for the establishment of all facilities necessary for the work on the project; for the costs of obtaining the required permits, bonds, and insurance; and for all other work and operations which must be performed, or costs incurred prior to beginning work on the various items of the project.
- 2. Unit of Measurement: None
- 3. Measurement: No measurement will be made for MOBILIZATION.
- 4. Payment: No separate payment will be made for MOBILIZATION.

B. Bid Item No. 1, 3, & 5-. – WATERBORNE PAINT STRIPING-WHITE:

- 1. Description: This item includes supplying and installing waterborne paint markings. Refer Appendix A Paint Striping Locations and Descriptions for the limits of the work. Paint markings shall be applied to match the existing paint markings as they are encountered in the field or as otherwise directed by the Owner. Crosswalk and stop bar marking is excluded from this bid item.
- 2. Work required under this section shall include, but not be limited to the following:
 - a. Providing material submittals;
 - b. Preparing surface for paint marking application;
 - c. Providing temporary traffic control;
 - d. All labor, tools, equipment, materials, royalties and incidentals required to complete the work as specified.
- 3. Unit of Measurement: Gallon
- 4. Measurement: WATERBORNE PAINT STRIPING-WHITE will be measured to the nearest gallon of applied and accepted paint marking.
- 5. Payment: Payment for WATERBORNE PAINT STRIPING-WHITE will be made at the contract unit price per gallon as indicated in the Bid Form.

C. Bid Item No. 2, 4, & 6. – WATERBORNE PAINT STRIPING-YELLOW:

- 1. Description: This item includes supplying and installing waterborne paint markings. Refer Appendix A Paint Striping Locations and Descriptions for the limits of the work. Paint markings shall be applied to match the existing paint markings as they are encountered in the field or as otherwise directed by the Owner.
- 2. Work required under this section shall include, but not be limited to the following:
 - a. Providing material submittals;
 - b. Preparing surface for paint marking application;
 - c. Providing temporary traffic control;
 - d. All labor, tools, equipment, materials, royalties and incidentals required to complete the work as specified.
