SECTION 00410 – BID FORM:

Remove page 3 of the Bid Form and replace it with the attached Bid Form reducing the quantity of Tack Coat, SS-1 to 40 Gallons.

Section 00910 – SPECIAL PROVISIONS

SP-07 TACK OIL: *Remove the first sentence and replace it with the following: Tack oil shall be SS-1 or equivalent upon approval by the engineer and shall meet the requirements of MPW Section 02502.*

SECTION 01275 – MEASUREMENT AND PAYMENT

Bid Item No. 5 – TACK COAT, SS-1, Item 2.a:

remove item a and replace with the following: Supplying SS-1 tack coat oil or equivalent.
