

RESOLUTION 2014 - 44

**A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL BENEFITED
PROPERTY WITHIN THE APPLGATE RURAL IMPROVEMENT
DISTRICT NO. 1994-6**

WHEREAS, the Board of County Commissioners of Lewis and Clark County (the "County") has properly created a rural improvement district (the "District") pursuant to Montana Code Annotated, Title 7, Chapter 12, Part 21, as amended (the "Act"), through Resolution 1994-190, denominated Rural Improvement District No. 1994-6 (the "District"), and undertaken certain local improvements (the "Improvements") to benefit property located therein; and

WHEREAS, Section 7-12-2161, MCA, provides that the Board of County Commissioners may, before the first Monday in September of each year, pass and finally adopt a resolution levying and assessing all the property within the district, an amount equal to the whole cost of maintaining, preserving, or repairing the improvements within the district; and

WHEREAS, Resolution 2005-44 provides for the levying and assessing of properties within the district for the purpose of repayment of debt and on-going maintenance; and

WHEREAS, the seven year debt assessment established through Resolution 2005-44 was levied for nine tax years; and

WHEREAS, MCA§7-12-2165 provides the Board of County Commissioners the authority to make all necessary orders to correct, reassess and relevey the same, including the ordering of work with the same force and effect as if made at the time, provided by the law or resolution relating thereto; and

WHEREAS, a reduction in the ongoing maintenance assessment for a period of two years would be sufficient to correct the error; and

WHEREAS, each parcel will be assessed a reduction assessment of \$12.07 per year for Tax Years 2014 and 2015; and

WHEREAS, the Tax Year 2016 assessment will revert to the amount established through Resolution 2005-44 (\$41.29) unless the Commission establishes an alternative assessment per MCA§7-12-2161; and

WHEREAS, the property owners of lots within the Applegate Rural Improvement District were notified pursuant to MCA§7-12-2159, MCA.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lewis and Clark County, that this resolution shall supersede Resolution 2005-44 and shall be levied and assessed upon all benefited properties, within the boundaries of Rural Improvement District No. 1994-6.


BE IT FURTHER RESOLVED that a corrective assessment of \$12.07 to be levied for Tax Years 2014 and 2015 and an ongoing maintenance assessment to be levied for Tax Year 2016 and perpetually thereafter, unless an assessment is established per MCA §7-12-2161.

BE IT FURTHER RESOLVED that a description of each parcel of land, the name of each owner, if known, and the amount of each estimated annual assessment is listed on Exhibit "A", attached hereto and made a part thereof.

BE IT FURTHER RESOLVED that the assessment amount contained on attached Exhibit "A" shall be made in two equal payments by the day and month specified on the annual tax notice. Payments made after the specified dates shall be delinquent. Assessments will be placed on the 2015 Tax Year billing.
