

**A RESOLUTION TO CREATE RURAL  
IMPROVEMENT DISTRICT NO. 2006-5 FOR THE BEL AIR ADDITION**

WHEREAS, a resolution of intention to create Rural Improvement District No. 2006-5 was adopted by the Board of County Commissioners on October 17, 2006, as Resolution 2006-116; and

WHEREAS legal notice of the passage of Resolution 2006-116 was mailed to property owners in the proposed district and printed in the local newspaper in accordance with the statutory requirements; and

WHEREAS, on December 12, 2006, the Board of County Commissioners held a public hearing and proceeded to hear all protests, comments, and other matters relating to the proposed district, and determined that the boundaries of the district benefit area and the method of assessment were equitable; and

WHEREAS, the Board examined the protest received pursuant to Section 7-12-2112(1)(a) through (c) and found the following:

under part (a) the protest received constituted 4.444%; under part (b) the protest received constituted 4.503%; and under part (c) the protest received constituted 3.797% and it was determined that this was not sufficient protest to bar proceeding.

NOW, THEREFORE, BE IT RESOLVED by the Lewis and Clark County Board of County Commissioners that it does hereby create the Bel Air Rural Improvement District No. 2006-5 for the purpose of improving and maintaining the roads in the Bel Air Addition.

BE IT FURTHER RESOLVED that said district shall include all lands developed as Bel Air Additions No. 1 and No. 2 and the lots established on Certificates of Survey No. 294017 and 322673, as shown on the attached Exhibit "A" and listed on Exhibit "B", attached hereto and made a part thereof. All lots within the district would benefit and would be assessed a flat fee for the improvements.

BE IT FURTHER RESOLVED that the engineer for the improvements is Stahly Engineering and Associates.

BE IT FURTHER RESOLVED that the improvements could include, but are not limited to: surface preparation, pulverization, shaping, compacting, installation of base course, double-shot chip-seal, trim brush, clean gutters and catch basins, drainage improvements and curb repair and/or replacement.

BE IT FURTHER RESOLVED that the estimated annual costs for said improvements are \$35,160.94 for a period of ten (10) years. All funds collected for the improvement district shall be spent solely for the road improvements within the proposed district.



BE IT FURTHER RESOLVED that all properties within the district would benefit and would be assessed a flat fee for the improvements. Each lot of record shall be assessed a flat fee of approximately \$781.35 per year for a period of ten (10) years, as shown and described on Exhibit "B".

BE IT FURTHER RESOLVED that a district for maintenance of the improvements shall be established, and that the boundaries of said maintenance district and the method of assessment for such maintenance shall be the same as the previously described improvement district.


BE IT FURTHER RESOLVED that the initial maintenance of the improvements shall include street sweeping, crack sealing, and signage. Additional maintenance activities could include a reserve account for future chip-seal applications, pavement patching, resurfacing, snow plowing, sanding, drainage control, and other maintenance and repair as necessary to preserve the road surfaces.

BE IT FURTHER RESOLVED that the estimated annual costs for said initial maintenance are \$9,018.36. Each lot shall be assessed approximately \$200.41 per year for said maintenance. All funds collected for the maintenance district shall be spent solely for the road maintenance activities within the proposed district.



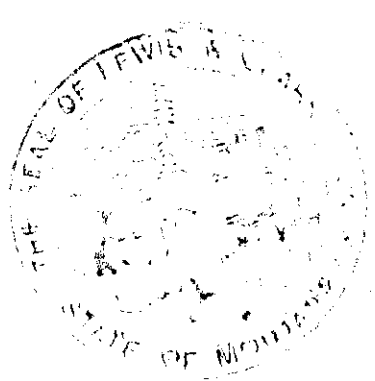

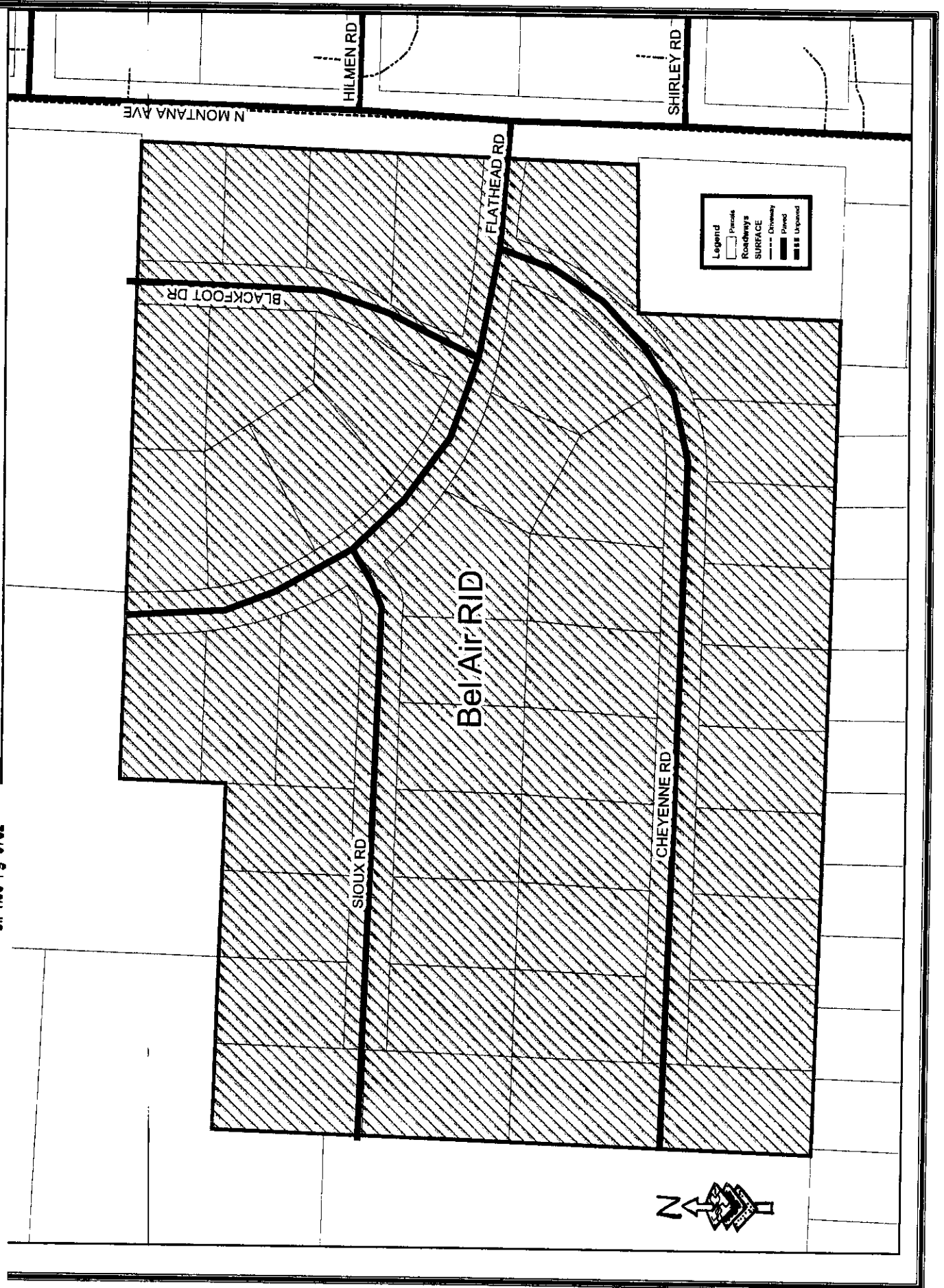
