

RESOLUTION NO. 1992 - 116

**A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL BENEFITED PROPERTY WITHIN THE BEARTOOTH ROAD RURAL IMPROVEMENT DISTRICT.**

**WHEREAS**, the Board of County Commissioners created, through Resolution No. 1992-56, the Beartooth Road Rural Improvement District; and,

**WHEREAS**, the County Commissioners approved a repayment schedule for the improvement loan as shown on the attached Attachment A and made a part of this resolution by reference and,

**WHEREAS**, the repayment schedule anticipates payment of a levy and assessment by the property owners within the district on or before November 30, of each year and May 31 of each year, with the levy and assessments becoming delinquent on December 1, and June 1; and,

**WHEREAS**, the listing of property owners within the district, Attachment B, includes a description of each lot, the name of the owner, and the amount of each partial payment, with the attachment being made a part of this resolution by reference herein; and,

**WHEREAS**, state law (7-12-2158 MCA) requires the County Commission to "by resolution levy and assess a tax upon all benefitted property in the district...".

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEWIS AND CLARK COUNTY**, adopts this resolution to levy and assess a tax upon all benefitted property within the boundaries of the district, as more particularly set forth in Attachment B; and,

**BE IT FURTHER RESOLVED**, that the property owners of the Beartooth Road Rural Improvement District shall be notified, through a mailing to each property owner, with a posting of three (3) notices within the district, and the publishing of an advertisement within the local paper, of the levy and assessment of a tax for the making of improvements to the Beartooth Road; and,
