

A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL BENEFITED PROPERTY WITHIN RURAL IMPROVEMENT DISTRICT NO. 91-3 BEARTOOTH ROAD

WHEREAS, the Board of County Commissioners properly created and established the Beartooth Rural Improvement District No. 91-3, through Resolution 1992-56; and

WHEREAS, Section 7-12-2158, MCA, provides that the Board of County Commissioners shall by resolution levy and assess a tax upon all benefited property in a district created for such purpose; and

WHEREAS, Resolution 1992-56 provides a mechanism for assessing benefited properties based upon the benefits received; and

WHEREAS, revenues generated by existing tax levy for the rural improvement district are not sufficient to adequately maintain the road; and

WHEREAS, the Beartooth Road committee has stated that the existing method of assessment is not equitable and has requested that the Board of County Commissioners change the method of assessment to a flat fee per geocode method; and

WHEREAS, the property owners of lots within the Beartooth Rural Improvement District were notified pursuant to Section 7-12-2159, MCA; and


NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lewis and Clark County, that an annual assessment of \$125.00 per year per geocode for road maintenance activities shall be levied and assessed upon all benefited property within the boundaries of Rural Improvement District No. 91-3.

BE IT FURTHER RESOLVED that a description of each parcel of land, the name of each owner, and the amount of annual assessment for each parcel is contained on Exhibit "A", attached hereto.

BE IT FURTHER RESOLVED that the assessment amount contained on attached Exhibit "A" shall be made in two equal payments by the day and month specified on the annual tax notice. Payments made after the specified dates shall be delinquent.
