## RESOLUTION 2002 - 86

## A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL BENEFITED PROPERTY WITHIN THE BIG VALLEY ROAD **IMPROVEMENT DISTRICT NO. 93-5**

WHEREAS, the Board of County Commissioners properly created and established the Big Valley Road Improvement District No. 93-5, through Resolution 1993-159; and

WHEREAS, Section 7-12-2158, MCA, provides that the Board of County Commissioners shall by resolution levy and assess a tax upon all benefited property in a district created for such purpose; and

WHEREAS, Resolution 1993-159 provides a mechanism for assessing benefited properties based upon the benefits received; and

WHEREAS, the property owners of lots within the Big Valley Road Improvement District were notified pursuant to Section 7-12-2159, MCA; and

WHEREAS, a rate hearing was held on July 9, 2002 and Resolution 2002-63 was passed with the new rates; and

WHEREAS, seven properties were inadvertently left off the assessment sheet attached to Resolution 2002-63.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lewis and Clark County, that an annual assessment of \$160.00 per lot for developed lots and \$80.00 per lot for undeveloped lots for road maintenance activities shall be levied and assessed upon all benefited property within the boundaries of Road Improvement District No. 93-5.

BE IT FURTHER RESOLVED, that this resolution is only adding the properties missed, which are in the district and have been assessed for the RID in the past.

BE IT FURTHER RESOLVED that a description of each parcel of land, the name of each owner, and the amount of annual assessment for each parcel is contained on Exhibit "A", attached hereto.

BE IT FURTHER RESOLVED that the assessment amount contained on attached Exhibit "A" shall be made in two equal payments by the day and month specified on the annual tax notice. Payments made after the specified dates shall be delinquent.
