

RESOLUTION 1983-50 M3-9950

RESOLUTION CREATING A ROAD MAINTENANCE DISTRICT FOR EASTGATE VILLAGE - PHASE II - ROAD MAINTENANCE DISTRICT #002 AND LEVYING OF ASSESSMENTS

WHEREAS the Board of County Commissioners established Rural Special Improvement District 1979-1, Eastgate Village II, under provisions of their Resolution of Intention to Create an RSID for improvements including creation and development of streets and dated May 21, 1979, Resolution 1979-13; and

WHEREAS those streets were dedicated to Lewis and Clark County for maintenance purposes with a maintenance district to be created to defray the costs of said improvements; and

WHEREAS 7-12-2161, MCA, authorizes the Board of County Commissioners to make such an assessment; and

WHEREAS, the work will be contracted out rather than being performed by the Lewis and Clark County Road Department and on which bids will be accepted on a competitive basis;

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners authorizes the creation of Road Maintenance District No. 002, Eastgate Village II; and

BE IT FURTHER RESOLVED that it has been determined by the Board of County Commissioners that the cost for said maintenance shall be assessed on the basis of 2,618,582 per square foot and shall be assessed against the total area of 2,618,582 square feet at a cost per square foot of \$ .0028 per square foot as provided in 7-12-2108, MCA; and

BE IT FURTHER RESOLVED that a list of property owners and lot descriptions be attached and made a part hereof; and

BE IT FURTHER RESOLVED that an assessment list be included as part of the property owners list showing due dates of November 30 and May 31 of each year and showing delinquency dates of December 1 and June 1; and

BE IT FURTHER RESOLVED that the first assessment shall be due and payable on or before November 30, 1983; and

BE IT FINALLY RESOLVED that five percent (5%) of the total assessment will be taken out of the road maintenance district fund and deposited in the general fund to defray expenses associated with the administration of the road maintenance district.

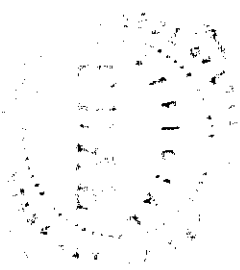
