

RESOLUTION 2003 - 59

**A RESOLUTION TO CREATE RURAL IMPROVEMENT DISTRICT 2003-1
TO INCLUDE THE LOTS IN THE GABLE ESTATES MAJOR SUBDIVISION**

WHEREAS, a resolution of intention to create Rural Improvement District No. 2003-1 was adopted by the Board of County Commissioners on April 1, 2003, as Resolution 2003-35; and

WHEREAS, legal notice of the passage of Resolution 2003-35 was mailed to property owners in the proposed district and printed in the local newspaper in accordance with the statutory requirements; and

WHEREAS, on May 20, 2003, the Board of County Commissioners held a public hearing and proceeded to hear all protests, comments, and other matters relating to the proposed district, and determined that the boundaries of the district benefit area and the method of assessment were equitable; and

WHEREAS, it was determined that there was not sufficient protest to bar proceedings; said protests constituting 0% of the cost of the proposed work.

NOW, THEREFORE, BE IT RESOLVED by the Lewis and Clark County Board of County Commissioners that it does hereby create the Gable Estates Rural Improvement District No. 2003-1 for the purpose of equitably funding road improvements and maintenance within said district. The district shall remain in effect in perpetuity or until such action by the Board of County Commissioners otherwise dissolves the district.

BE IT FURTHER RESOLVED that the district shall include those parcels of land abutting and/or accessing the roads in the Gable Estates Major Subdivision and that the boundaries of the district are shown on Exhibit "A".

BE IT FURTHER RESOLVED that the improvements include shaping, base course, application of asphalt to roadway, cul-de-sacs and driveway approaches, and a chip-seal application one year after the initial improvements.

BE IT FURTHER RESOLVED that the estimated annual costs for said improvements are 60,340.32 for a period of ten (10) years. All funds collected for the improvement district shall be spent solely for the road improvements within the proposed district.

BE IT FURTHER RESOLVED that all properties within the district would benefit equally and would be assessed a flat fee for the improvements. Each lot of record shall be assessed a flat fee of approximately \$1,257.09 per year for a period of ten (10) years, as shown and described on Exhibit "B".

BE IT FURTHER RESOLVED that a district for maintenance of the improvements shall be established, and that the boundaries of said maintenance district and the method of assessment for such maintenance shall be the same as the previously described improvement district.

BE IT FURTHER RESOLVED that the initial maintenance of the improvements may include contributions to a reserve account for future surface treatment (e.g. chipseal). Additional maintenance activities could include pavement patching, crack sealing, resurfacing, snow plowing, sanding, street



sweeping, drainage control, signage, and other maintenance and repair as necessary to preserve the road surfaces.

BE IT FURTHER RESOLVED that the estimated annual costs for said initial maintenance are \$8,911.00. Each lot shall be assessed approximately \$185.65 for said maintenance. All funds collected for the maintenance district shall be spent solely for the road maintenance activities within the proposed district.

BE IT FURTHER RESOLVED that the districts shall remain in effect in perpetuity or until such action by the Board of County Commissioners otherwise dissolves the districts.
