## RESOLUTION 2013 - 75

## A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL BENEFITED PROPERTY WITHIN THE LIME KILN ROAD RURAL IMPROVEMENT DISTRICT NO. 1993-3

WHEREAS, the Board of County Commissioners properly created and established the Lime Kiln Road Rural Improvement District No. 1993-3, through Resolution 1993-128; and

WHEREAS, Section 7-12-2158, MCA, provides that the Board of County Commissioners shall by resolution levy and assess a tax upon all benefited property in a district created for such purpose; and

WHEREAS, Resolution 1993-128 provides a mechanism for assessing benefited properties based upon the benefits received; and

WHEREAS, the property owners of lots within the York Road Rural Improvement District were notified pursuant to Section 7-12-2159, MCA; and

WHEREAS, Resolution 1993-128 established an annual assessment of \$350.00 per lot for road maintenance activities to be levied and assessed upon all benefitted properties within the boundaries of the Rural Improvement District; and

WHEREAS, Lewis and Clark County has reviewed the maintenance costs and have determined that the District is collecting more revenue than is necessary and has proposed that the rate be decreased.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lewis and Clark County, that an annual assessment of \$220.00 per lot for road maintenance activities shall be levied and assessed upon all benefited property within the boundaries of Rural Improvement District No. 1993-3.

BE IT FURTHER RESOLVED that a description of each parcel of land, the name of each owner, and the amount of annual assessment for each parcel is contained on Exhibit "A", attached hereto.

BE IT FURTHER RESOLVED that the assessment amount contained on attached Exhibit "A" shall be made in two equal payments by the day and month specified on the annual tax notice. Payments made after the specified dates shall be delinquent.
