

RESOLUTION 1994 - 152

A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL BENEFITED PROPERTY WITHIN THE LIME KILN ROAD AND SOUTH HILLS ROAD IMPROVEMENT DISTRICT.

WHEREAS, the Board of County Commissioners properly created and established the lime Kiln Road and south Hills Road through Resolution of Intention to Create a Rural Improvement District #1993-128 and Resolution to Create the Lime Kiln Road and south Hills Road Improvement District #19943-157; and

WHEREAS, the listing of property owners within the district, as shown on Attachment A, includes a description of each lot, the name of the owners, and the amount of each partial payment, with said attachment being made a part of this resolution by reference herein; and

WHEREAS, Section 7-12-2158, MCA, provides that the Board of County Commissioners shall by resolution levy and assess a tax upon all benefited property in the district created for such purpose; and

WHEREAS, the property owners of the Lime Kiln Road and South Hills Road Improvement District were notified of the levy and assessment pursuant to Section 7-12-2159, MCA.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lewis and Clark County, that a tax shall be levied and assessed upon all benefited property within the boundaries of the Lime Kiln Road and South Hills Road Improvement District as particularly set forth in Attachment "A"; and

BE IT FURTHER RESOLVED, that all partial payments are due and become delinquent as provided in Section 15-16-102, MCA.

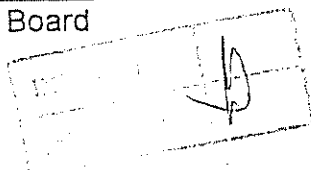
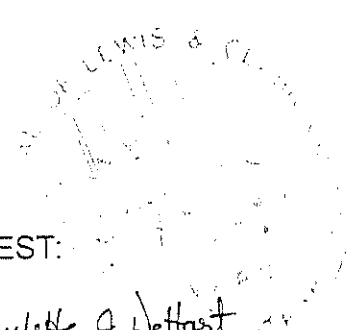
