

A RESOLUTION ALTERING THE BOUNDARIES OF THE PLEASANT VALLEY LIGHTING DISTRICT #1981-1 AND LEVYING ASSESSMENTS TO DEFRAY THE COST OF MAINTENANCE WITHIN THE DISTRICT

WHEREAS, the Board of County Commissioners established R.S.I.D. #1981-1 for Pleasant Valley Subdivision by adopting Resolution 1982-46, on September 7, 1982, for the purpose of operating and maintaining a lighting system and furnishing electrical energy thereto; and

WHEREAS, Section 7-12-2202, M.C.A., allows the Board of County Commissioners to adopt a resolution levying and assessing upon all the property within the district an amount equal to the whole cost of maintaining said lighting system; and

WHEREAS, a petition has been received by the Board of County Commissioners requesting alteration of the Pleasant Valley Lighting District to include both sides of Kitt Drive, both sides of Kismet Drive, both sides of Karla Drive and both sides of Kandy Drive; and

WHEREAS, the additional lighting facilities are more specifically described as serving lots 42-49, 52-59, 62-69, 72-79, 82-89, 92-99, 102-109, and 128-135 inclusive; and

WHEREAS, the proposed facilities will consist of twenty-four (24) units with underground wiring, steel poles and glass enclosed luminaires; and

WHEREAS, the monthly cost per unit is \$11.44; and

WHEREAS, the estimated annual cost of maintenance and electrical energy shall be paid by the property owners; the estimated assessment to be made and paid by the property owners

per year will be on the basis of approximately \$.00515 per square foot of property owned; and

WHEREAS, the assessment for the first year will include the costs to the County for the formation of the Special Improvement District; and

WHEREAS, the first year assessment may be as high as \$69.00 to defray initial District alteration costs; and

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS RESOLVES to alter the boundaries of the Pleasant Valley Lighting Maintenance District to include lots listed in Exhibit "A" and shown on a map in Exhibit "B" which are attached to this resolution and by this reference are hereby made a part thereof.
