A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL BENEFITED PROPERTY WITHIN THE RURAL SPECIAL IMPROVEMENT DISTRICT NO. 1985-1 AKA RIDDOCK SUBDIVISION RURAL SPECIAL IMPROVEMENT DISTRICT.

WHEREAS, the Board of County Commissioners properly created and established Rural Special Improvement District No. 1985-1 aka the Riddock Subdivision Rural Special Improvement District through Resolution of Intention to Create a Rural Special Improvement District #1985-33 and Resolution to Create a Rural Special Improvement District #1985-33A; and

WHEREAS, the listing of property owners within the district, as shown on Attachment A, includes a description of each lot, the name of the owners, and the amount of each partial payment, with said attachment being made a part of this resolution by reference herein; and

WHEREAS, Section 7-12-2158, MCA, provides that the Board of County Commissioners shall by resolution levy and assess a tax upon all benefited property in the district created for such purpose; and

WHEREAS, the property owners of the Riddock Subdivision Rural Special Improvement District were notified pursuant to Section 7-12-2159, MCA.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lewis and Clark County, that a tax shall be levied and assessed upon all benefited property within the boundaries of the Rural Special Improvement District No. 1985-1 aka the Riddock Subdivision Rural Special Improvement District as particularly set forth in Attachment "A"; and

BE IT FURTHER RESOLVED, that all partial payments are due and become delinquent as provided in Section 15-16-102, MCA.

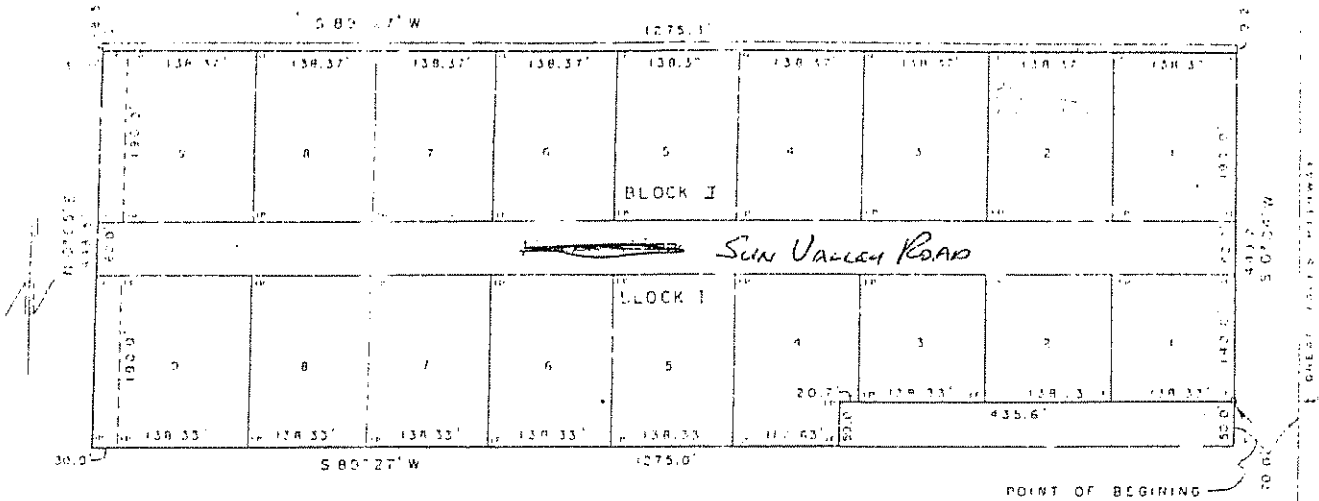
