RESOLUTION OF INTENTION TO CREATE THE LAKE HOME ROAD RURAL IMPROVEMENT DISTRICT NO. 2020-1

WHEREAS, the Lewis and Clark County Board of Commissioners may order and create a Rural Improvement District (RID) whenever the public interest of convenience may require, Section 7-12-2102, MCA; and

WHEREAS, it is the policy of the Board to follow public process for creating an RID when a petition has been received to create an RID; and

WHEREAS, a petition for the Lake Home Road Rural Improvement District No. 2020-1 (the District) was submitted April 11th, 2020, for the purpose of funding improvements and maintenance for the extent of Lake Home Road; and

WHEREAS, the petition was signed by 78% of owners of benefited lots within the District boundary; and

WHEREAS, the designated items set forth in Section 7-12-2103(2), MCA, are as follows:

(a) The designated number of the District is 2020-1.

(b) The benefited properties to be included in the District are listed in the petition, Exhibit "A". The road proposed to be improved and maintained within the boundary of the District is shown on Exhibit "B".

(c) The County Engineer or a designee is the engineer to have charge of the work. The general character of improvements includes an asphalt overlay, installation of valley gutters, and chip seal. The estimated costs for improvements are \$33,389.53, or \$4,219.73 per year for a period of ten (10) years. Each benefited property will be assessed \$301.41 annually. Improvement costs are detailed in Exhibit "C".

(d) The general character of maintenance includes, but is not limited to chip sealing, crack sealing, snow plowing, sweeping, and other maintenance and repair as necessary to preserve the road surfaces. Each benefited property will be assessed \$47.81 annually. Maintenance costs are detailed in Exhibit "D".
(e) Costs shall be assessed equally, as described in Section 7-12-2151(1)(d), MCA.

(f) Pursuant to Section 7-12-2103(2)(f), MCA, if an increase in the number of benefited lots, tracts, or parcels within the boundaries of the district during the term of bonded indebtedness, the assessment per lot, tract, or parcel then in the district will be recalculated.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners does hereby establish its intention to create the Lake Home Road Rural Improvement District No. 2020-1 for the purpose of equitably funding improvements and maintenance for Lake Home Road.

BE IT FURTHER RESOLVED that written protests will be received from persons owning real property within the proposed district for thirty (30) days after the first publication of notice, and that said protests must contain the printed landowner's name and address as it appears on the last assessment roll.


