

RESOLUTION NO. 2007-125

A RESOLUTION LEVYING AN ASSESSMENT UPON BENEFITTED PROPERTY IN THE COUNTY OF LEWIS AND CLARK, MONTANA, RURAL IMPROVEMENT DISTRICT NO. 2005-3, TO REPAY A SPECIAL ASSESSMENT BOND ISSUED FOR THE PURPOSE OF DEFRAYING THE COST OF WASTEWATER IMPROVEMENTS THEREIN.

BE IT RESOLVED by the County Commission of the County of Lewis and Clark (the "County"), Montana (the "County"), as follows:

Section 1. The County passed Resolution No. 2007-110 on September 6, 2007, declaring its intention to levy an assessment upon benefitted property in the County to repay a special assessment bond issued for the purpose of benefiting property in the District described in Resolution No. 2007-83, for wastewater improvements within the District.

Section 2. The County published a notice of its intention to levy an assessment in the Helena Independent Record on September 9 and September 16, 2007. The notice included the time and place of the hearing to object to the levy. The County Commission held the hearing on October 2, 2007 at 9:00 a.m., and considered objections.

Section 3. After considering the objections the County Commission determined that the assessment should be levied as indicated in Resolution No. 2007-110.


Section 4. The County hereby levies total assessments and annual assessments against each of the properties in the District as indicated on Exhibit A, attached hereto and made a part hereof.

Section 5. The County will deliver a copy of this Resolution, to the appropriate County officials to levy the assessments for the 2007 tax year.


Section 6. The annual assessments may be split in half and paid in semi-annual installments, which are due on November 30th and May 31st of each year and will be delinquent if not paid on such dates.
