- 2. Authorization of Fund 297 WGSCR (00:16:31)
 - a) Microscope; Noxious Weed Planner (00:16:31) (Christian Lehnert)
 - Will be used for in house identification
 - Generally, cost is around \$200-\$300
 - o Tabled until next meeting; staff will provide quotes
 - b) Weed Pulling Gloves & Stamp with Clothing Ink- Promo Item (00:20:20) (Jade Wills)
 - Staff explains the request to purchase poly dipped gloves that can be stamped with LCC
 Noxious Weed District name & phone number to distribute as a promo item.
 - Request for this purchase will be e-mailed out as staff would like it to be approved and move forward with the purchase for the HBIA Home & Garden Show.
 - Staff will more than likely propose purchasing the stamp & 400 gloves (350 size large, 50 size extra-large)
 - Stamp estimated \$30-45; Gloves \$1.25/pair, Staff will see if a discount is possible for a bulk purchase.
 - c) Name Tags; Board/Staff
 - The Board has previously requested quotes on name tags; Helena Stamp has quoted approximately \$12-\$15/each
 - Staff will e-mail out the request to use Fund 297 for the purchase of all board member/staff name tags to move forward with this purchase.
 - o If approved will proceed in hopes of having the name tags completed and available at the HBIA Home & Garden Show.
