**RESOLUTION OF INTENT TO CREATE A RURAL IMPROVEMENT DISTRICT
FOR AMERICAN BAR ROAD NUMBER 2013-2**

WHEREAS, whenever the public interest or convenience may require, the board of county commissioners may order and create a special improvement districts outside of the limits of incorporated towns and cities for the purpose of building, constructing, or acquiring by purchase one or more of the improvements in or for the benefit of the special improvement district; and

WHEREAS, a petition, containing the signatures representing 60% percent of the properties to be included within the District was received by the County; and

WHEREAS, the resolution of intention designates items set forth in MCA §7-12-2103(2):


- (a) The designated number of the district is 2013-2.
- (b) The boundaries are shown on attached Petition Exhibit A and described on Petition Exhibit B located in Sections 2, 11 & 12, Township 12 North, Range 3 West, P.M.M. and Sections 6 & 7, Township 12 North, Range 2 West, P.M.M., Lewis and Clark County, Montana.
- (c) The general character of the maintenance include repair, preservation and maintenance of the portion of gravel road, described in the Petition and shown on Petition Exhibit A.
- (d) Dowl HKM is the engineer to have charge of the work and the estimated cost for said maintenance is \$11,000 per year or \$100 per lot, tract or parcel per year.
- (e) All parcels within the proposed district would benefit and would be assessed using MCA §7-12-2151(1)(d) Each lot, tract, or parcel of land in the district may be assessed an equal amount based upon the total cost of the improvement.
 - o All funds collected for the district shall be spent solely for the maintenance activities within the proposed district.



NOW, THEREFORE LET IT BE RESOLVED, by the Lewis and Clark County Board of County Commissioners that it does hereby intend to create the Big Sky Rural Improvement District 2013-2.

PETITION TO CREATE A RURAL IMPROVEMENT DISTRICT PER MCA §7-12-2102 TO RESURFACE AND MAINTAIN PORTIONS OF BEAVER CREEK ROAD AND AMERICAN BAR ROAD LEWIS & CLARK COUNTY

We the undersigned, owners of real property within the proposed American Bar Rural Improvement District, within Lewis and Clark County, do hereby petition the Board of County Commissioners to create the American Bar Rural Improvement District ("District"), as authorized by §7-12-2102, MCA. The purpose of District shall be to resurface and maintain a portion of American Bar Road (from its intersection with Forest Service Trail #1812-B1, southeast, to its intersection with Forest Service Trail #138 (a.k.a. Beaver Creek Road), approximately 2.8 miles) and a portion of Beaver Creek Road (from its intersection with Forest Service Trail #1812 (a.k.a. American Bar Road), east, to the southwest corner of property geocode number 0521125201010000, approximately 2.1 miles). The boundaries of the proposed district and the portions of road to be resurfaced are shown on the attached Exhibit "A". The proposed improvement includes resurfacing portions of the serviced road. Maintenance activities could include grading, excavation, compaction, culverts, gravel application, snow plowing, sanding, drainage control, and other maintenance and repair as necessary to maintain, repair and preserve the road surfaces. The total estimated annual cost for said improvements and maintenance is \$11,000.00.

Benefited lots, tracts or parcels of land in the district shall be assessed an equal amount based upon the total cost of the improvement. The assessment per lot, tract or parcel per year would be \$100.00. Attached as Exhibit "B" is a list of lots within the proposed Rural Improvement District which shows the property identification number, owner, legal description, and the estimated annual assessment for each lot. Exhibit "B" also shows the signatures of the property owners petitioning for the creation of the district. All funds collected for the District shall be spent solely for the roads serviced by the District.

It is anticipated that the District would be administered by the County, unless an agreement is entered into between the County and a representative body of the property owners within the District. The County will serve only to coordinate the necessary work, collect the assessments, and disburse payments for the district. It is anticipated that a private contractor would perform the maintenance.

This petition is being circulated in accordance with the Lewis and Clark County Rural Improvement District and Rural Maintenance Districts Policies and Procedures manual which is on file and available for inspection on the Lewis & Clark County Board of County Web Site or at the Special District Coordinator's Office. Because of aggregation and subdivision of parcels, the actual number of parcels state in the petition may change between the time the petition is circulated and the time the board considers the resolution of intention to create the Rural Improvement District and therefore, the actual assessment per parcel may be greater than or less than the amount stated in the petition.

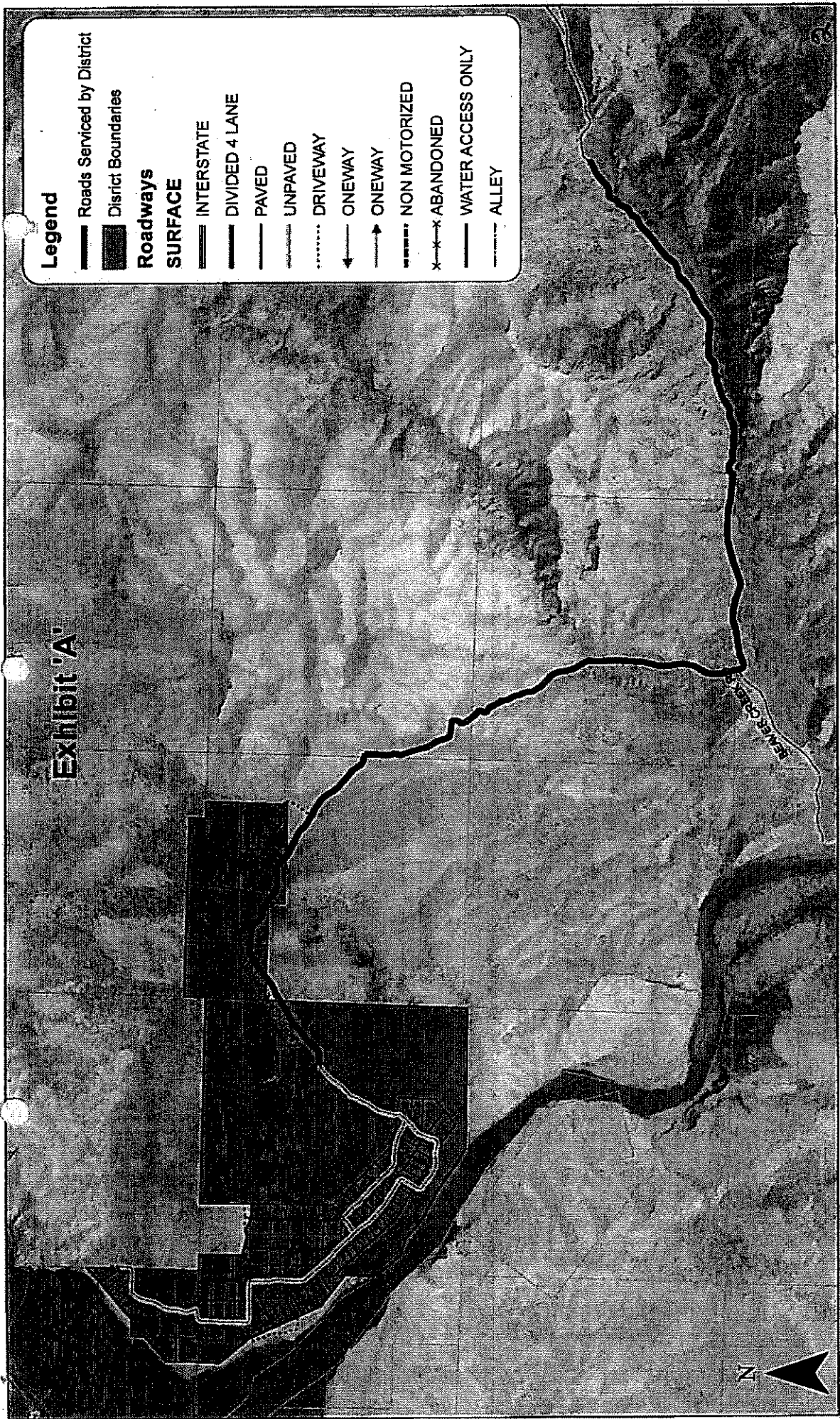

PETITION TO CREATE A RURAL IMPROVEMENT DISTRICT PER MCA §7-12-2102 TO RESURFACE AND MAINTAIN PORTIONS OF BEAVER CREEK ROAD AND AMERICAN BAR ROAD

We the undersigned, owners of real property within the proposed American Bar Rural Improvement District, within Lewis and Clark County, do hereby petition the Board of County Commissioners to create the American Bar Rural Improvement District ("District"), as authorized by §7-12-2101, et. Seq., MCA. The purpose of District shall be to service a portion of American Bar Road (from its intersection with Forest Service Trail #1812- B1, southeast, to its intersection with Forest Service Trail #138 (a.k.a. Beaver Creek Road), approximately 2.8 miles) and a portion of Beaver Creek Road (from its intersection with Forest Service Trail #1812 (a.k.a. American Bar Road), east, to the southwest corner of property geocode number 0521125201010000, approximately 2.1 miles). The boundaries of the proposed district and the portions of road to be resurfaced are shown on the attached Exhibit "A". The proposed improvement includes resurfacing portions of the serviced road. Maintenance activities could include grading, excavation, compaction, culverts, gravel application, snow plowing, sanding, drainage control, and other maintenance and repair as necessary to maintain, repair and preserve the road surfaces. The total estimated annual cost for said service is \$11,000.00.

Benefited lots, tracts or parcels of land in the district shall be assessed an equal amount based upon the total cost of the improvement. The assessment per lot, tract or parcel per year would be \$100.00. Attached as Exhibit "B" is a list of lots within the proposed Rural Improvement District which shows the property identification number, owner, legal description, and the estimated annual assessment for each lot. Exhibit "B" also shows the signatures of the property owners petitioning for the creation of the district. All funds collected for the District shall be spent solely for the roads serviced by the District.

It is anticipated that the District would be administered by the County, unless an agreement is entered into between the County and a representative body of the property owners within the District. The County will serve only to coordinate the necessary work, collect the assessments, and disburse payments for the district. It is anticipated that a private contractor would perform the maintenance.

This petition is being circulated in accordance with the Lewis and Clark County Rural Improvement District and Rural Maintenance Districts Policies and Procedures manual which is on file and available for inspection on the Lewis & Clark County Board of County Web Site or at the Special District Coordinator's Office. Because of aggregation and subdivision of parcels, the actual number of parcels state in the petition may change between the time the petition is circulated and the time the board considers the resolution of intention to create the Rural Improvement District and therefore, the actual assessment per parcel may be greater than or less than the amount stated in the petition.

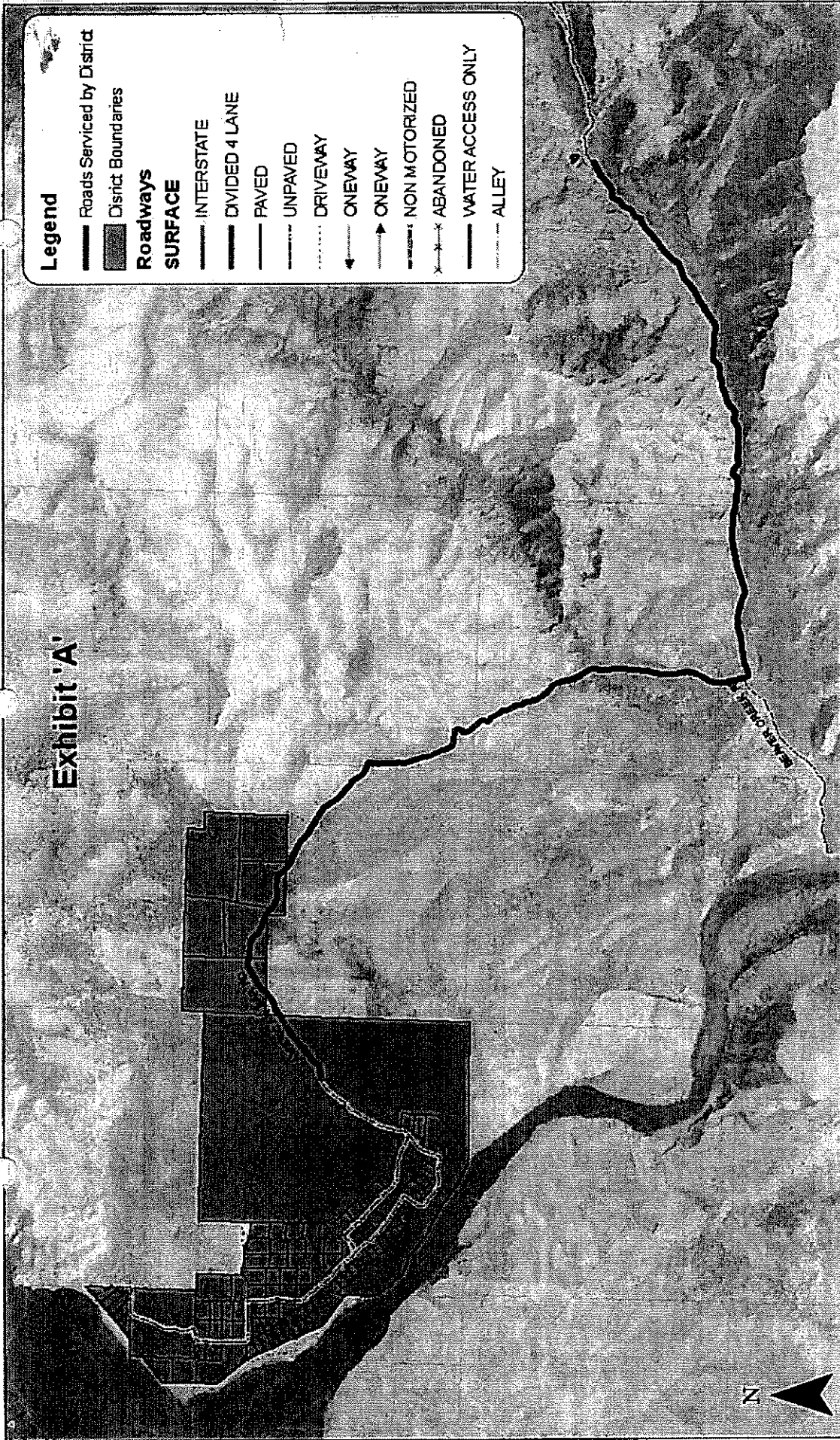




